## OPINION

In this proceecing the Seinroed Cominsion is asked to enter its order authorizing Wililam Lampert end Weurice Strain to execute an agreement similar to that attached to the potition and marked "Exibit $A$ ", and to waich agreement reference wil bis mace herearter.

It is of record that Winism: Lampert bes beem engaged in conductine a feed me seod business and in operatinga public utility warehouse orisiness in the City of Meryevilic. Ee reports his investrent in the properties referred to in this application at $\$ 31,000.00$. Els gross reverues for 1930 emovintod to个23,952.03, of whick $\$ 4,984.52$ was obtained from warehouse operntions. Bocause of 117 health he hans sold his feed and seed basiness and desires to withdraw from the operetion of a public utility rarehouse business. Eis warehouse operations beve besm iimited to the storing of ince, grain and beans.

Tnder date of February 28, 1931 Tililam Lampert has agreed. to 1 ease and sell to Maurice Strain, according to the terms of the agreoment iniod in this proceeding as Bxhibit "A" the foilowing described real and personal propenties:

Thder the terms 0 the aforesaic agreement, Wilifam Lampert has agreed to lease to Marice Strain the properties to maich re=erence bas deen made for a torm of ten yeans, commenctns on the first day of March, 1931, end enaing on the 28th day oif Februery, 1941, for a total rental of $\ddagger 36,000.00$, parable in equal ronthly instailments of $\$ 300.00$ per month on the first day of each and every mowh beginming Narch 1 , 2931 during the term of the leese. The agreement forther grants to Narrice Strain the sole and exciusive right end option to purchase the properties at any time during the inst IIve years of the term, for the toter price of $\$ 33,000.00$. In the event the lessee does net exercise the opticn to purchese the properties brt continues to operate them as tenart, the iessor will give him a
credit or retond of $\$ 2,000.00$ on the ifnol year's rent.
:iaurice Strain intends to continue the operation of the public utility warehonse business. Ee plens to install on the premises a bean cleaner at a cost of about $\$ 8,000.00$. If the parties exercise the authority herein granted, Nanice Strain mist conkuct the prbile utility warehouse business poder the rates showe in warehouse Tarifi No. 2, C.R.C. NO. 2, IIIed by Eilliam Lamport on Vay 31, 1923. Such rates may not be increased except as authorized by the comassion:

II IS HEREBY FURTHER ORDERED, that nefthor the ègreed rental nor the purchase price provided in the agreement herefn authorized to be executed shail hereatier be urged betore this Comission as dete=mining the value of the propertios described in said agreement for the purpose of fixing rates or issuing securities.
