ORDER

Pacific Gas and Electric Company having asked permission to sell to Coast Counties Gas and Electric Company, its successors or assigns, free and clear of all encumbrances, that certain 22 K.V. pole and wire line, approximately 6.41 miles in length and extending between Burns Station and Point Murretti in the County of Santa Cruz, more particularly described in Exhibit "A" filed in this proceeding, a public hearing having been held before Examiner Fankhauser, and the Commission having considered the evidence submitted at such hearing and being of the opinion that this application should be granted, subject to the provisions of this order, therefore,

IT IS HEREBY ORDERED that Pacific Gas and Electric Company be, and it is hereby, authorized to sell, assign, transfer

and convey, on or before December 31, 1931, to Coast Counties Gas and Electric Company, all of the properties which the former has agreed to sell, assign, transfer and convey unto the latter, pursuant to the provisions of the agreement dated August 15, 1931 and filed in this proceeding as Exhibit "A".

IT IS HEREBY FURTHER ORDERED that Pacific Gas and Electric Company and Coast Counties Gas and Electric Company are hereby authorized to execute a deed substantially in the same form as the deed filed in this proceeding and made a part of the aforesaid agreement dated August 15, 1931 and filed in this proceeding as Exhibit "A".

IT IS HEREBY FURTHER ORDERED that the authority herein granted to sell, assign, transfer and convey the aforesaid properties is subject to the condition that applicants shall not urge before this Commission that the consideration which Coast Counties Gas and Electric Company has agreed to pay for said properties determines the value of said properties for any purpose other than the transfer herein authorized.
