Applicant alleges that no passenger or freight business was transacted at any of the said non-agency stations during the year ending June 30, 1931, except at Pacific Spur, where 48 passenger tickets were sold and 8 carloads of freight business handled during the year, and that, in applicant's opinion, the continued

GG:CAO maintenance of said non-agency stations is not necessary for the business of applicant or the convenience of the public. Pacific Lumber Company, the only shipper at Pacific Spur, signified by letter, under date of January 30, 1932, that it does not object to the granting of the Company's application to abandon this non-agency station. The Commission's engineers have made an investigation of this matter and have recommended that the application be granted and, it now appearing that a public hearing is not necessary herein, IT IS HEREBY ORDERED that Northwestern Pacific Railroad . Company is hereby authorized to abandon said non-agency stations as tabulated below: Line or Branch Station County Pagan1 Sonoma Valley Branch Sonoma Kenilworth Sebastopol Branch Sonoma Casini Guerneville Branch Sonoma Spur 9 Sherwood Branch Mendocino Pacific Spur Main Line Humboldt Humboldt P. L. Spur Main Line Drake Humboldt Main Line Bayside Humboldt Bayside Junction Main Line Humboldt Carlotta Branch Burnell Humboldt H.N.R.R.Crossing Samoa Branch Humboldt and to eliminate said non-agencies' names from its station records and to cancel, in conformity with the rules of this Commission, all rate tariffs and time schedules applying to said stations, subject to the following conditions: Applicant shall notify the public of the abandonment of said non-agencies by posting a suitable notice for at least ten (10) days in advance of the effective time of this change in a conspicuous place at each of the said non-agency stations. (2) Applicant shall, within thirty (30) days there-after, notify this Commission, in writing, of the abandonments herein authorized and of its compliance with the conditions hereof. -2(3) The authorization herein granted shall lapse and become void if not exercised within one (1) year from the date hereof, unless further time is granted by subsequent order.

The authority herein granted shall become effective on the date hereof.
