O P I N I O N

Applicant herein seeks Motor Carrier Transportation Agent's License for its main office and for four hundred and ninety (490) branch offices in California. Applicant is now operating passenger transportation service by authority of Decision No. 23244 and subsequent decisions and under such certificates does not require a license as Chapter 638, Statutes of 1931, page 1362 is not made applicable to such carriers. The licenses are asked for the purpose of selling tickets for Pickwick-Greyhound of California, Ltd., operating as an interstate carrier and as such ticket vendor is amenable to the provisions of the Motor Carrier Transportation Agent Act. Its request to sell tickets for Union Pacific Stages was withdrawn, in writing, March 8, 1932.

Applicant has answered all questions satisfactorily, has tendered its bond, as required, and has paid the fees required. The branch offices for which licenses are sought are the regular salaried or commission ticket agents of the carrier in its main intrastate business.

This appears to be a matter in which a public hearing is not necessary. The application should be granted.

Good cause appearing, IT IS HEREBY ORDERED that, upon compliance with the several conditions hereinafter set forth, the Secretary of the Railroad Commission of the State of California issue to Pacific Greyhound Lines, Inc., a corporation, a license to engage in the business of "motor carrier transportation agent", as such is defined by Statutes 1931, Chapter 638, page 1362, at
