W. Comph, Agent; and Items 14732, 14734, 14735 and 14738 of Supplements 52 and 54 to Pacific Freight Tariff Bureau Tariff Bureau Tariff 30-K, C.R.C. 473 of F. W. Comph, Agent, naming reduced rates on soap and related articles from San Francisco, Oakland, Alameda, San Leandro and Richmond to Mentone, Redlands, San Bernardino, Duarte, Pasadena, Los Angeles, Wilmington, Los Angeles Haroor, Redondo Beach, Los Nietos, Fullerton, Stern, Covina, Anaheim, Riverside, Colton, Santa

Ana, Glendale, Wingfoot, Long Beach, Whittier, Alhambra, Arrowhead, Patton, Highland, Sunkist, Greenspot and points grouped therewith, and from Los Angeles, Wilmington, Los Angeles Harbor, Redondo Beach, Long Beach, Wingfoot, Los Nietos, Pasadena, Duarte, San Bernardino, Riverside and points grouped therewith, to San Francisco, Oakland, Alameda, San Leandro and Richmond;

The matter was set for hearing before Commissioner Harris at San Francisco, April 15, 1932. Before the proceeding was heard however, respondents applied to the Commission and obtained authority to withdraw the suspended rates. Respondents subsequently asked for and obtained authority to publish rates on soap higher than those under suspension but in some cases lower than the present rates. By the readjustment outlined above the cause for suspension will be removed. Upon condition that the readjustment is made effective July 25, 1932 our order of March 28, 1932 will be vacated as of that date and this suspension proceeding discontinued.

## ORDER

Upon consideration of all the facts of record, and good cause appearing therefor,

IT IS HEREBY ORDERED that our order of March 28, 1932 in the above entitled proceeding be and it is hereby vacated and set aside as of July 25, 1932 and this proceeding be and it is hereby discontinued, subject to the condition set forth in the opinion which precedes this order.
