FIRST SUPPLEMENTAL ORDER

IT IS HEREBY ORDERED that Southern Pacific Company be and it is hereby authorized to maintain Standard No. 2 Crossing Signs in lieu of Standard No. 1 Crossing Signs as prescribed in the Commission's General Order No. 75, for the protection of certain crossings on its East Bay Electric Lines in the cities of Emeryville, Berkeley, Oakland and Alameda, at the locations shown on the attached tabulation and marked Exhibit "A."

In all other respects this Commission's orders in the above entitled proceeding shall remain in full force and effect.

The authority herein granted shall become effective
