EIGHTH SUPPLEMENTAL ORDER

In the Eighth Supplemental application, in the above entitled matter, Southern California Edison Company (now by change of name Southern California Edison Company Ltd.) asks authority to sell to City of Pasadena certain electrical distributing property not included among the properties transferred under the authority granted in Decision No. 7707, dated June 9, 1920, or subsequent supplemental orders.

It appears that Southern California Edison Company Ltd.

owns electrical distribution facilities in the City of Pasadena

and in the territory commonly known as Arroyo Seco Annexation No. 1

and Arroyo Seco Annexation No. 2, which have recently been annexed

to the City of Pasadena, and that Southern California Edison Company

Ltd. has agreed to sell and City of Pasadena has agreed to buy said

properties, at a price less than the historical cost thereof, of

Two Thousand Eight Hundred Ninety-four Dollars and Forty-five cents

(2,894.45).

The Commission has considered this request and is of the opinion it should be granted; therefore,

IT IS HERERY ORDERED that Southern California Edison Company Ltd. be and it is hereby authorized to sell and transfer to the City of Pasadena for the sum of Two Thousand Eight Hundred Ninety-four Dollars and Forty-five Cents (\$2,894.45) those certain distribution facilities more particularly described in the bill of sale designated as Exhibit "A" (attached to and made a part of applicant's Eighth Supplemental Application) and located within the City of Pasadena and within the boundaries of the new annexation commonly known as Arroyo Seco Annexation No. I and Arroyo Seco Annexation No. 2 and to issue and deliver to the City of Pasadena a Bill of Sele substantially in the form of the aforementioned Exhibit "A."

The foregoing authorization is granted subject to the following conditions and not otherwise:

- 1. That the transfer of ownership of said properties shall be consummated on or before January 1, 1933.
- 2. That immediately following said transfer of ownership Southern California Edison Company Ltd. shall file with this Commission a certified copy of the Deed of Sale.
