OPINION and ORDER

This is a joint application by Southern California Edison Company Ltd., Los Angeles Gas and Electric Corporation, and Southern Sierras Power Company for an order approving a certain contract dated July 20, 1932, made and entered into by and between applicants and The Metropolitan Water District of Southern California covering the furnishing of electric power by the former to the latter for use in connection with the construction of The Metropolitan Water District Aqueduct from the Colorado River. A copy of said contract, together with Notice Inviting Bids, Instructions to Bidders, Proposal, Bidding Sheets and Specifications, is submitted with the application.

Under the terms and conditions, and during the term specified in the contract, applicants agree to furnish electric

power to said District as follows:

Term of Contract 5½ years from date of commencement of delivery of power.

Point of Delivery Colton Substation of Southern California Edison Company Ltd.

Maximum Demand 23,000 K.W. plus 4,000 K.W. if demanded.

Voltage 63,000 Volts three phase.

Frequency 50 cycles.

Rate, (All three charges additive)

(1) Service Charge

\$1500.00 per month for 66 months.

(2) Demand Charge

95¢ per month per kilowatt of maximum demand.

(3) Energy Charge

5 mill per kilowatt hour.

Minimum Charge

\$3,000.00 per month, cumulative annually during first year.

Power Factor Clause

Same as Edison Schedule P-1.

Meter Location, High Side.

Maximum Demand, 30-minute interval, 11 P.M. to 6 A.M. excluded.

Fuel Clause

Increase of 3¢ per thousand K.W.H. for each 1¢ per barrel above 75¢ per barrel of fuel oil F.O.B. Long Beach Steam Plant.

The Commission being of the opinion that said agreement is fair to all parties; that applicants' request should be granted; that a public hearing in this matter is not necessary and good cause appearing therefor.

IT IS HEREBY ORDERED that the above mentioned contract between Southern California Edison Company Ltd., Los Angeles Gas and Electric Corporation, Southern Sierras Power Company, and

The Metropolitan Water District of Southern California  
be and the same is hereby approved.
