## FOURTh SUPPLEMENTAL OPINION AND ORDER

This is a supplemental application by the Los Angeles Railway Corporation for an order authorizing it to reroute the bar line not operating along pines Avenue sad wittier Borioverd. It is proposed to change the route established dy Decision No. 23e3n to the 20110 wing:

From the intersection of \#hattion Boriorand and Stains avenue, thence tia whittier Boulevard, Fore Boulevard, East 9 th Street, mines avenue, East 8 th Street, Soto Street, East eth Street, Central avenue, East eth Street, Los Angeles Street, past 7 in Street, San Jitiden Street to East eth Street and theme return tia the going route.
Applicant alleges that the route used in twang its busses at the westoriy terminus has been via 7 th Street, Wall Street and fin Street; that the whoiesele Lower market 0 L Los Angeles is located along Tain Street between 7th and eth Streets; that the Southern Ceifiomafa Florists Association has complained to the Board of Pubic Utilities end Transportation of the City of Ios Angeles, requesting the the route now used in turning the busses at the westerly terminus bo changed and that applicant has agreed with said Board, if permitted by this Commission, to operate over the route herein proposed.
