OPINION AND ORDER

This is an application by San Joaquin Light and Power Corporation for an order of the Railroad Commission authorizing the filing and making effective, on less than statutory notice, and for the period specified, the rates, charges and conditions set forth in applicant's proposed Electric Schedule S-P-10 as follows, which schedule is marked Exhibit "A," attached to and made a part of said application:

SCHEDULE S-P-10
TEMPORARY ELECTRIC SERVICE
FOR
WINTER IRRIGATION

Limited to Service
October 1st, 1932 to April 1st, 1933

SERVICE:

Applicable to service employed in the irrigation and preparation of land for the production of crops to come into maturity during the year 1933, and where required service facilities already exist.

TERRITORY:

Entire territory served.

RATE:

SPECIAL CONDITIONS:

(a) The period during which this schedule will be available shall be limited to the period October 1st, 1932 to April 1st, 1933.

(b) Any irrigation pumping plant to which consumer may have terminated service prior to October 1st, 1932, may qualify for service under this schedule provided the prior account is in good standing.

(c) This schedule in no respect cancels or supercedes Schedule S-P-3, but is optional thereto for service to plants for which service has previously been terminated.

The application sets forth that:

Said proposed schedule is to be applicable to electric service employed in the irrigation and preparation of land for the production of crops to come to maturity during the year 1933, where required service facilities already exist. Under the provisions of said schedule, service will be furnished to consumers qualifying for the same without the making or collecting by applicant of any demand charge for electric service supplied to consumers under said schedule. Applicant is proposing said last mentioned schedule with the view of encouraging and assisting agriculturists situated in the territory served by applicant to operate their pumping plants during the coming winter months for the fortification of vines or trees for healthful production in the year 1933, or for the preparation of their lands and sowing of grain for 1933 production; that said proposal is made possible by reason of the unusual conditions now obtaining upon applicant's electric production, transmission and distribution systems and, in particular, an abundance of stored water and electric energy available for distribution and sale; and applicant is informed and believes and therefore says that the filing and making effective of said proposed Schedule S-P-10 will be of great advantage and value to consumers operating under said schedule and will redound to the benefit of applicant in that there will result, during the period said schedule is in force and effect, an increased demand for electric service, and a more general use of applicant's electric plants and facilities devoted to the service of the public.

The Commission, having given careful consideration to this application and being of the opinion that the same should be granted; that a public hearing in the matter is not necessary and just cause appearing, therefore

IT IS HEREBY ORDERED that San Joaquin Light and Power Corporation be and it is hereby authorized to file and make effective, for the period in said schedule specified, the rates, charges and conditions set forth in Schedule S-P-10 as hereinbefore quoted.

The effective date of this order is the date hereof.
