## OPINION

Railway Express Agency, Incorporated, of California makes its first supplemental application for an enlargement of its certificated rights as granted by Decision No. 24134, dated October 19, 1931, on Application No. 17447, by which it may receive or deliver shipments of the Railway Express Agency, Incorporated, of Delaware not only at Sacramento but also at Stockton, Elk Grove, Galt and Lodi when such traffic originates at or is destined to Rio Vista end contiguous points.

A public hearing was held before Examiner Brown at San Francisco December 15, 1932.

Applicant is now authorized to transport between Rio Vista and Sacramento all property tendered the Delaware corporation for transportation. It appears that frequently shipmonts destined to Southern California points. Arizona and points east thereof, cannot be assembled in time to connect with afternoon

trains at Sacramento. Many of these shipments if delivered to trains at other points between Sacramento and Stockton would materially shorten the time in transit. The authority herein sought would not in any way enlarge the territory now served nor alter the existing rates.

The application will be granted as supplemental to and amending the order made in Decision No. 24134, dated October 10, 1931, on Application No. 17447.

## <u>C R D E R</u>

Railway Express Agency, Incorporated, of California, having made application for authority to receive or deliver shipments assembled at points between Rio Vista and Sacramento and receive or deliver such shipments at termini other than Sacramento, to-wit: Kik Grove, Galt, Lodi and Stockton,

IT IS HEREEY ORDERED that Decision No. 24134 on Application No. 17447 be and the same hereby is amended as follows:

Applicant is authorized in the transportation of the shipments tendered to Railway Express Agency, Incorporated, of Delaware to receive or deliver such shipments at Sacramento, or, as emergency may require, at Elk Grove, Galt, Lodi or Stockton solely to make train connections, the receipt or delivery of such shipments being limited to such property as shall have been tendered Railway Express Agency, Incorporated, of Delaware for transportation from or to points beyond Elk Grove, Galt, Lodi or Stockton.
