ORDER

Northwestern Pacific Railroad Company, a corporation, on December 14, 1932, filed with the Commission a request for authority to discontinue the operation of passenger trains between Manor and Point Reyes, Marin County. The application recites that the revenue derived from passengers and express transported by these trains is less than the cost of maintaining the service; that if the permission is granted applicant will arrange for the honoring of railroad tickets on the proposed stage service of Pacific Greyhound Lines, Inc. between Manor and Point Reyes and that applicant's patrons will be afforded an adequate substitute by use of said stage service.

In Application No. 18588, Pacific Greyhound Lines, Inc. has made application for a certificate of public convenience and necessity to operate a passenger service as a common carrier between Manor and Point Reyes and that the schedules proposed by it are comparable to those now operated by the railroad company.

It appears that this is not a matter in which a public hearing is necessary and that the application should be granted, therefore,

IT IS HEREBY ORDERED that Northwestern Pacific Railroad Company is hereby granted authority to discontinue the operation of all passenger and mixed train service between Manor and Point Reyes, Marin County, coincident with the establishment of passenger stage service by Pacific Greyhound Lines, Inc., substantially as applied for in Application No. 18588, and to cancel all time schedules between said points, subject to the following conditions:

- (1) Applicant shall make arrangements with Pacific Greyhound Lines, Inc., to the effect that tickets of applicant shall be honored on the stages operated by said Pacific Greyhound Lines, Inc. between Manor and Point Reyes.
- (2) Applicant shall afford the public at least five days' notice of this discontinuance of train service by posting notices in all stations located on the line between Manor and Point Reyes and in all cars and trains operating between these points.
- (3) Applicant shall, within thirty (30) days thereafter notify this Commission, in writing, of the abandonment of passenger service herein authorized and of its compliance with the conditions hereof.
- (4) The authorization herein granted shall lapse and become void if not exercised within one (1) year from the date hereof unless further time is granted by subsequent order.

The effective date of this Order shall be the date hereof.
