O R D E R

The City of Los Angeles, on November 4, 1932, applied for authority to reconstruct and widen a public overhead crossing known as Tunnel Station Bridge on the Newhall Pass Road, at separated grades over the main line track of Southern Pacific Company between San Fernando and Newhall, in the City of Los Angeles, County of Los Angeles, State of California. Southern Pacific Company, on January 3, 1933, signified, in writing, that it has no objection to the widening of said overhead crossing. Applicant signified, in writing, on March 28, 1933, that it was agreeable to paying the entire cost of this improvement.

It appearing that a public hearing is not necessary herein; that it is in the interest of public convenience and necessity that the overhead crossing be reconstructed and widened and that the application should be granted, subject to certain conditions,

IT IS HEREBY ORDERED that the City of Los Angeles is hereby authorized to reconstruct and widen a public road known as Newhall Pass Road at separated grade over the main line track

of Southern Pacific Company between San Fernando and Newhall, in the City of Los Angeles, County of Los Angeles, State of California, at the location as shown by the plans (Exhibits "A" and "B") attached to the application, subject to the following conditions:

- (1) The above crossing is identified as Crossing No. 9-456.5-a.
- (2) The entire expense of constructing and thereafter maintaining the crossing in good and first-class condition for safe and convenient use of the public shall be borne by applicant.
- (3) Applicant shall file, for approval, within ninety (90) days from the date hereof and prior to the commencement of construction, a set of plans for said crossing, which plans shall have been approved by applicant and Southern Pacific Company.
- (4) Said crossing shall be constructed with clearances conforming to the provisions of our General Order No. 26-C.
- (5) Applicant shall, within thirty (30) days thereafter, notify this Commission, in writing, of the completion of the installation of said crossing and of its compliance with the conditions hereof.
- (6) The authorization herein granted shall lapse and become void if not exercised within one (1) year from the date hereof unless further time is granted by subsequent order.

The authority herein granted shall become effective on the date hereof.
