ORDER

In this proceeding Claude B. Robinson and W. H. Robinson, co-partners doing business under the fictitious name of Robinson Bros. Transfer and Storage Company, have made application to the Railroad Commission in which they petition for an order authorizing them to sell and James Little to purchase a certain automobile track line authorized to operate as a common carrier of freight between Los Angeles and Glendale, California.

The operative right herein proposed to be transferred was originally obtained by Robinson Bros. under the provisions of Section 5 of Chapter 213, Statutes of 1917, due to their operation prior to the effective date of said Act and continuously since that time.

The consideration to be paid for the property herein proposed to be transferred is given as the sum of \$3,500.00 and includes in addition to the operative right two Auto-Car trucks together with supplies, stationery and miscellaneous equipment.

It appearing to the Commission that this is a matter in which a public hearing is not necessary.

IT IS HEREBY ORDERED that the above entitled application be, and the same hereby is granted subject to the following conditions:

- l. That the consideration to be paid for the property herein authorized to be transferred shall not be binding upon this Commission for rate fixing or any purposes other than the transfer herein authorized.
- Z. That applicants Claude B. Robinson and W. H. Robinson, co-partners, shall immediately cancel all tariff of rates and time schedules now on file with the Railroad Commission, such cancellation to be in accordance with the provisions of General Order No. 51 and other regulations of the Commission.
- 3. That applicant James Little shall immediately file, in duplicate, tariff of rates and time schedules in his own name, or adopt as his own the tariff of rates and time schedules heretofore filed by applicants Claude B. Robinson and W. H. Robinson, co-partners, all tariff of rates and time schedules to be identical with those filed by applicants Claude B. Robinson and W. H. Robinson.
- 4. That the rights and privileges herein authorized to be transferred may not be discontinued, sold, leased, transferred nor assigned unless the written consent of the Railroad Commission to such discontinuance, sale, lease, transfer or assignment has first been secured.
- 5. That no vehicle may be operated by applicant James Little, unless such vehicle is owned by said applicant or is leased by him under a contract or agreement on a basis satisfactory to the Railroad Commission.
