SECOND SUPPLEMENTAL ORDER

WHEREAS, in Decision No. 9412 in the above entitled matter, this Commission provided with reference to the rates therein established that upon approval of the Railroad Commission, Schedule No. 1 would be subject to increase or decrease on the basis of 2.4 cents per 1000 cubic feet for each 10 cents increase or decrease respectively, in the price of oil, above or below the price of \$1.75 per barrel at San Diego; and that Schedule No. 3 would be subject to decrease on the basis of 3 cents per 1000 cubic feet for each 10 cent decrease in the cost of oil below the price of \$1.65 per barrel at San Diego, and,

WHEREAS, San Diego Consolidated Gas and Electric Company having horetofore filed with this Commission an affidavit that the price paid for oil had been reduced by the total of 35 cents per barrel for Schedule No. 1, and 25 cents per barrel for Schedule No. 3, and the Commission having in consequence, in Decision No. 10777, ordered a reduction of 8 cents per 1000 cubic feet on both schedules, and,

WHEREAS, San Diego Consolidated Gas and Electric Company now makes affidavit that on August 8, 1922, the price paid for oil at San Diego was reduced to \$1.15 per barrel, this being a further reduction of 25 cents and a total reduction of 60 cents

per barrel for Schedule No. 1 and a total reduction of 50 cents per barrel for Schedule No. 3 from the base prices on which rates were established in Decision No. 9412,

IT IS HEREBY OMDERED that the rates set forth in Decision No. 9412 in Application No. 6078 designated as Schedule No. 1, be and they are hereby reduced by 14 cents per 1000 cubic feet and the rates designated as Schedule No. 3, be and they are hereby reduced by 15 cents per 1000 cubic feet, reductions on both schedules to be effective for all regular meter readings taken on and after September 8, 1922, this being a further reduction from rates now in effect of 6 cents per 1000 cubic feet for Schedule No. 1, and of 7 cents per 1000 cubic feet for Schedule No. 3.

IT IS HEREBY FURTHER ORDERED, that Sun Diego Consolidated Gas and Electric Company file with the Commission on or before September 8, 1922, a revision of its schedules to comply with this Order.
