FIRST SUPPLEMENTAL ORDER.

The Railroad Commission having by its Order dated the First day of July, 1922. Decision No. 10652, authorized the Santa Barbara Telephone Company to sell and The Pacific Telephone and Telegraph Company to purchase certain telephone property located in the cities of Santa Barbara and Santa Maria for the sum of Two Thousand One Hundred and Ninety-Four Dollars and Seventy Cents (\$2,194.70), said property being more specifically described in the said order of the Commission and the said Santa Barbara Telephone Company and The Pacific Telephone and Telegraph Company having advised the Railroad Commission in a letter dated the Twenty-eighth day of August, 1922 that the said sale and purchase was intended to include certain associated central office equipment which was not included in the property described in said order, and said companies having in their letter of August 28, 1922 requested permission to have the transfer at the price set forth in said order record-
