O P I N I O N

East Bay Water Company, a public utility water corporation operating in the so-called East Bay district of Alameda and Contra Costa counties, in the above entitled application asks for authority to extend its existing mains in Richmond, California, to supply the Nystrom School, a public school recently constructed in what is known as the Santa Fe Tract.

It is stated in the application that East Bay Water Company has not heretofore supplied service in the said Santa Fe Tract, such distribution being supplied by the McEwen Brothers System. It is further stated in the application that representations were made to the applicant by the City Attorney of Richmond to the effect that the McEwen Brothers Water System is unable to furnish an adequate supply of water for the school and for fire protection purposes, it being the desire of the City to have a

hydrant installed at the end of the main opposite the school.

Public hearing was held in this matter before Examiner Satterwhite on August 30, 1922.

From the testimony of applicant, it appears that the proposed main is to extend along Tenth Street, from applicant's 12" main at Ohio and Tenth Streets, to the school property at Tenth and Main Streets and that it is not its desire in making this extension to invade the territory now being served by the McEwen Brothers System, except, that it desires to be given permission to serve such consumers on Tenth Street, along the line of extension, as may make application for service.

McEwen Brothers offer no objection to the proposal of applicant, except that East Bay Water Company be restrained from furnishing water to corner lots of streets intersecting Tenth Street, crossed by the proposed main. East Bay Water Company indicated that such arrangement was entirely satisfactory to it.

O R D E R

East Bay Water Company having made application as entitled above, a public hearing having been held and the matter having been submitted for decision,

IT IS HEREBY ORDERED that East Bay Water Company be and the same is hereby authorized to install a water main in what is known as the Santa Fe Tract, Richmond, California, from its existing main at Tenth and Ohio Streets, in a southerly direction along Tenth Street, a distance of approximately one thousand (1000) feet to supply water service to the Nystrom School, install such fire hydrants on said main as are ordered by the City.

of Richmond, and to supply such other applicants for service on Tenth Street along the line of the proposed extension with the exception of corner lots at intersecting streets.
