ORDER

D. W. Renfro has filed an application with the Railroad Commission in which he petitions for a certificate of public convenience and necessity authorizing the operation of an automobile stage line for the transportation of school children only between Folsom, Orangevale and San Juan Union High School.

Applicant proposes to operate one Oldsmobile and one Reo truck in the proposed service and to operate such equipment at times convenient to carry school children to San Juan High School and return them to their homes just prior to and after school hours. No service is to be rendered on Saturdays, Sundays or holidays nor during any period of the year at which time the school is not open. A fare of \$6.00 has been agreed upon between Folsom and the high school and \$5.00 between Orangevale and the high school, one-half of which is to be paid by the school and one-half by the parents of the children transported.

There is an existing stage line operating as a common carrier over the route herein sought to be served, but their stages do not run at times convenient to transport school children. Although a letter was addressed to them requesting information as to whether or not they desired to protest the present ap-

plicant and no reply having been received thereto, we are of the opinion that this is a matter in which a public hearing is not necessary and that the application should be granted.

THE RAILROAD COMMISSION OF THE STATE OF CALIFORNIA HEREBY DECLARES that public convenience and necessity require the operation by D. W. Ramfro of an automobile stage line as a common carrier of school children only between Folsom, Orangevale and the San Juan Union High School, such service to be rendered during the period of the year and upon such days as the school is open,

IT IS HEREBY ORDERED that a certificate of public convenience and necessity be, and the same hereby is granted, subject to the following conditions:

1. Applicant herein shall file within a period of not to exceed ten (10) days from date hereof his written acceptance of the certificate herein granted and shall file within a period of not to exceed twenty (20) days from date hereof, in duplicate, tariff of rates and time schedules as per Exhibits "A" and "B" attached to the application.

2. The rights and privileges herein authorized may not be discontinued, sold, leased, transferred nor assigned unless the written consent of the Railroad Commission to such discontinuance, sale, lease, transfer or assignment has first been secured.

3. No vehicle may be operated by applicant herein unless such vehicle is owned by him or is leased by him under a contract or agreement on a basis satisfactory to the Railroad Commission.
