SEVENTH SUPPLEMENTAL ORDER IN APPLICATIONNO. 6425. SECOND SUPPLEMENTAL ORDER IN APPLICATION NO. 8329.

SOUTHERN CALIFORNIA EDISON COMPANY, by Decision No. 11107. dated October 14, 1922 in Application No. 6425, and by Decision No. 11104, dated October 14, 1922 in Application No. 8329, was authorized by the Commission to sell, in the aggregate, \$10,000,000.00 of its general and refunding mortgage five per cent. bonds of the Series of 1919, due February 1, 1944. The orders of the Commission, as amended from time to time, permit the use of \$4,561,853.79 of the proceeds to finance the cost of retiring underlying bonds and to pay for additions and betterments made prior to October 31, 1922. The remainder of the proceeds may be expended only for such purposes as the Commission might authorize in supplemental orders.

The company now reports, in supplemental petitions filed in the above matters on December 16, 1922, that during the month of

November its net expenditures for its Big Creek development were \$1,517,168.83, which expenditures have not been paid or provided for through the issue of stock or bonds.

Applicant asks permission to finance the above mentioned November construction expenditures with proceeds obtained from the sale of the bonds heretofore authorized by the Commission. It reports that there remains an unexpended balance of \$643,706.21 realized from the sale of the bonds authorized by Decision No. 11107, and \$3,844,440.00 from the sale of those authorized by Decision No. 11104.

The Commission has given consideration to applicant's request and believes that it should be granted as herein provided, therefore,

IT IS HEREBY ORDERED, that SOUTHERN CALIFORNIA EDISON COMPANY be, and it is hereby, authorized to use \$643,706.21 of the proceeds realized from the sale of the bonds authorized by Decision No. 11107, dated October 14, 1922, and \$873,462.62 obtained from the sale of the bonds authorized by Decision No. 11104, dated October 14, 1922, to finance the construction expenditures reported in the supplemental petitions filed in the above entitled matters on December 16,1922.

IT IS HEREBY FURTHER ORDERED, that the order in Decisions No. 11107, dated October 14, 1922, as amended, and No. 11104, dated October 14, 1922, as amended, shall remain in full force and effect, except as modified by this supplemental order.
