

Decision No. 11124.

BEFORE THE RAILROAD COMMISSION OF THE STATE OF CALIFORNIA.

ORIGINAL

In the Matter of the Joint Application of the SACRAMENTO VALLEY SUGAR COMPANY, a corporation, and PACIFIC GAS AND ELECTRIC COMPANY, a corporation, for an order of the Railroad Commission of the State of California authorizing the former to sell and convey and the latter to purchase and acquire the electric properties and business herein described.

BY THE COMMISSION:

FIRST SUPPLEMENTAL ORDER

Based upon proper showing by applicants of error on their part in describing in this application and proposed agreement the location of the property to be transferred thereunder, and upon further showing properly and correctly describing the location of the same, the body of the order in this Commission's Decision No. 11182 is hereby amended to read as follows:

Sacramento Valley Sugar Company has asked permission to sell to Pacific Gas and Electric Company, for the sum of \$2,000.00, an electric distribution system hereafter particularly described, and to cease furnishing electric service in the territory now supplied by this system. Pacific Gas and Electric Company has joined in this request.

Sacramento Valley Sugar Company, by means of this distribution system, supplied electric service to eight consumers in adjoining portions of Glenn and Butte Counties. The supplying of this service is purely incidental to the company's principal business of producing and refining sugar.

All energy thus distributed is purchased from Pacific Gas and Electric Company and supplied from its Hamilton City Sub-Station at which point its system is connected to the system which Sacramento Valley Sugar Company proposes to sell.

The Commission has considered these facts and is of the opinion that the interests of the consumers of Sacramento Valley Sugar Company and of the public can be better served by Pacific Gas and Electric Company with its better and more adequate facilities, and that this request should be granted; therefore

IT IS HEREBY ORDERED that Sacramento Valley Sugar Company be and it is hereby authorized to sell and transfer to Pacific Gas and Electric Company and Pacific Gas and Electric Company to purchase for the sum of \$2,000.00 that certain electric distribution system located in the Counties of Glenn and Butte, State of California, and more particularly described as follows:

Those certain three (3) phase 6600 volt pole and wire electric distribution lines (including transformers) together with the rights of way for the maintenance and operation of said lines, situate in the Counties of Glenn and Butte, State of California, belonging to Sacramento Valley Sugar Company and extending from the Hamilton City Sub-Station to the pumping plant formerly owned by the seller in Section 33, Township 23, North Range 1 West M.D.B. & M.

and more particularly shown and delineated on a blue print map filed in connection with this application and marked Exhibit "A", together with the contracts for furnishing and the business of supplying, electric energy to the consumers of Sacramento Valley Sugar Company who are now being furnished with electric energy by means thereof.

IT IS HEREBY FURTHER ORDERED that Sacramento Valley Sugar Company be and it is hereby authorized to cease furnishing

electric service in the territory now served by means of the property to be transferred and that Pacific Gas and Electric Company be and it is hereby authorized to begin and continue the business thus relinquished.

This authority is granted on the condition that the price for which this property is to be sold shall never be urged before this Commission or any other regulatory body as a measure of its value for rate fixing or for any purpose other than that which gave rise to this proceeding.

IT IS HEREBY FURTHER ORDERED that Decision No. 11182, dated October 30th, 1922, shall remain in full force and effect except as modified by this order.
