OPINION.

This is a proceeding to fix and determine the just compensation to be paid by the City of San Diego, an incorporated city, for the lands, property and rights of James A. Murray, Ed Fletcher and William G. Henshaw, co-partners engaged under the firm name and style of Cuyamaca Water Company (hereinafter referred to as Cuyamaca Company) in the business of selling water for municipal, domestic and irrigation purposes in San Diego County. This proceeding is brought under the provisions of Section 47 of the Public Utilities Act. This section provides in part that any incorporated city or town may file with the Railroad Commission a petition setting forth the intention of such incorporated city or town to acquire under eminent domain proceedings, or otherwise, any existing public utility, and the lands, property and rights of any character whatsoever connected with such existing public utility, or any part or portion thereof; that said petition shall

give a full and complete description of the property which it is: intended to acquire; that the Railroad Commission shall thereupon proceed to fix and determine the just compensation that shall be paid to the owner of the public utility for the lands, property and rights thereof, or any part or portion thereof, in accordance with the provisions of Section 70 of the Public Utilities Act; that the compensation fixed by the Railroad Commission in such proceeding shall be conclusive upon any court in which a proceeding for condemnation may thereafter be brought; that the Railroad Commission's findings shall be subject to review by the Supreme Court of this State in the same manner and within the same time as other orders and decisions of the Railroad Commission; and that if the Supreme Court shall decide that in any manner the/Commission has not lawfully pursued its power, the court shall make its finding and refer the matter back to the Railroad Commission for correction or further action.

The procedure to be followed in such proceeding is set forth in Section 70 of the Public Utilities Act.

The City of San Diego's petition herein alleges in part that the applicant is a municipal corporation operating under a freeholders' charter; that it is the intention of the City of San Diego to acquire under eminent domain proceedings certain land property and rights of an existing public utility, being an existing water system known as the Cuyamaca Water System, now operational conducted for the purpose of impounding, conserving and distributing water for municipal, domestic and irrigation pur which said public utility and the lands, property and right nected therewith are located in San Diego County and belowand are owned and controlled by James A. Murray, Ed Flet William G. Henshaw; that on January 4, 1915, the Common of the City of San Diego adopted Ordinance No. 5977 & that the public interest, convenience and necessity of San Diego and of the inhabitants thereof requires

construction and completion of the properties of the Cuyamaca Company, as described in the Ordinance, and declaring the intention of the City of San Diego to acquire under eminent domain proceedings such property and directing the City Attorney to commence an action in the Superior Court of San Diego County for the purpose of condemning and acquiring said property, a copy of which Ordinance is attached to the petition and marked Exhibit "A"; that attached to the petition and marked Exhibit "B" is a schedule of the lands, property and rights of the Cuyamaca Company which the City of San Diego intends to acquire by eminent domain proceedings and for which the City of San Diego asks the Railroad Commission to fix and determine the just compensation to be paid by the City of San Diego; that attached to the petition and marked Exhibit "C" is a schedule of a pertion of the lands, property and rights of the Cuyamaca Company which portion of said lands, property and rights the City of San Diego desires to acquire by eminent domain proceedings and for which portion of said lands, property and rights the City of San Diego asks the Railroad Commission to fix and determine the just compensation to be paid by the City of San Diego, in case it shall be determined by the courts that the City of San Diego has not the power to acquire title to the entire property described in Exhibit "B" attached to the petition; that the City of San Diego as the successor to the Ancient Mexican Pueblo of San Diego claims a prior and paramount right to the use for municipal purposes of the waters of the San Diego River and its tributaries, and that as to the water rights and water appropriations upon the San Diego River and its tributaries listed in Exhibits "B" and "C" attached to the petition, the City of San Diego disputes the right and title of James A. Murray, Ed Fletcher and William G. Henshaw; and that it is probable that an action will shortly be commenced by the City of San Diego in the courts of competent jurisdiction to

determine the rights of the City of San Diego in the waters of the San Diego River and that it would be desirable to have the Railroad Commission, in the present proceeding, state separately the value of the water rights and appropriations listed in said exhibits. The City of San Diego asks the Railroad Commission to fix and determine the just compensation to be paid by the City of San Diego for the lands, property and rights of the Cuyamans Company, as described in Exhibit "B" attached to the petition herein, and for that portion of the lands, property and rights which is described in Exhibit "C" attached to the petition herein and for such other and further relief as to the Railroad Commission may seem just and equitable.

Exhibit "A" attached to the petition herein, being a copy of Ordinance No. 5977 of the Common Council of the City of San Diego, contains exactly the same description of the property of the Cuyamaca Company as is attached to the contract dated November 17, 1914, between James A. Murray and Ed Fletcher, copartners doing business under the firm name and style of Cuyamaca Water Company, and La Mesa, Lemon Grove and Spring Valley Irrigation District, a copy of Which contract is attached to the petition in Application No. 1432, being the joint application of Murray and Fletcher and the Irrigation District for an order fixing and determining the price to be paid by the Irrigation District to the Cuyamaca Company for its lands, property and rights and authorizing the Cuyamaca Company to sell said lands, property and right to the Irrigation District at such price. Reference is hereby made to the opinion and order this day rendered in said Application No. 1432.

Exhibit "B" attached to the petition herein contains the same property descriptions as are described in said Ordinance No.5977 and in the contract of November 17, 1914, between Murray and Fletcher and the Irrigation District.

Exhibit "C" attached to the petition herein, contains a description of the portion of the lands, property and rights and of the Cuyamaca Company hereinbefore referred to/ describes the same property as that which appears in Exhibit "B" except that the following omissions are made:

- 1. From the first schedule, describing real property other than easements, Exhibit "C" omits the following parcels of land:
 - a. Poverty Gulch Reservoir site.
 - b. Webster Reservoir site.
 - c. Park Reservoir site, also known as Miles No. 1
 Reservoir site.
- 2. From the second schedule, describing rights of way, federal rights granted and pending, flowage rights and riparian rights, the following items are omitted:
 - a. Item No. 1 Permit issued by United States

 Department of Agriculture, Forest Service, for a canal upon

 Boulder Creek, dated July 2, 1914.
 - b. Item No. 2 Application to United States

 Department of Agriculture, Forest Service, for final power

 permit on Boulder Creek, filed June 6, 1914 temporary

 permit to proceed with construction issued July 3, 1914,

 and final stipulation signed August 3, 1914.
 - c. Item No. 3 Contract to occupy lands and right of way for flume within the El Capitan Indian Reservation with United States Department of the Interior, originally made with the San Diego Flume Company, as recorded in the office of the Commissioner of Indian Affairs at Washington, D.C., as per letter from Department of Interior to Commissioner of Indian Affairs, dated September 16, 1892.

d. Item No. 4 - Amended right of way for concrete pipe line at Sand Creek over land in the El Capitan Indian Reservation, approved by United States Indian Service June 25, 1913, as per departmental letter of July 29, 1913.

- e. Item No. 5 Amended right of way for steel pipe line at South Fork Camyon over the El Capitan Indian Reservation, granted in 1912.
- f. Item No. 6 Application for lands for reservoir purposes and easements for Conejos Reservoir, pending, filed with the United States Department of the Interior in May, 1912, stipulations for a payment of \$2600 for lands to the Indian Bureau having been signed in 1914.
- g. Item No. 7 Permit for the use of public lands
 for reservoir purposes in Poverty Gulch Reservoir site, July
 26, 1913, being approximately 40 acres in the southwest quarter
 of the southeast quarter and the southeast quarter of the northeast quarter of Section 3, Township 15 south, range 3 east
 S.B.M.
- h. Item No. 8 Permit to occupy lands within the El Capitan Indian Reservation for pumping purposes, granted by United States Department of the Interior, dated September 12, 1913.
- i. Item No. 11 A general right of way for pipe lines through all lots in La Mesa Colony.
- 3. From the third schedule, being a list of physical structures and improvements, the following items are omitted:
 - a. The City of El Cajon's distributing system, partly installed and partly under construction.
 - b. The Grossmont Tract system, consisting of a reservoir in lot No. 449 in Grossmont Tract, subdivision No. 3, and a reservoir in lot No. 21 and a reservoir near lot No. 75 of Grossmont Tract subdivision No. 1, together with all pipe lines connecting these reservoirs and other distributing lines

laid upon the private ways within these subdivisions up to and including meters of the consumers and the pipe line known as the Helix pipe line.

- c. The water system in the streets of Murray Hill.
- d. The water system in the streets of Hawley Heights.
- e. The wood stave pipe supplying North La Mesa, approximately 8,000 feet long.

- g. Wagons and tools now in use by Company.
- 4. From the fourth schedule, being water appropriations, there is omitted the following item:
 - a. Item No. 7 Permit for appropriation of water for power purposes of State Water Commission on Boulder Creek in Section 10, Township 14 south, range 3 east, S.B.M., for 50 cubic feet per second, filed May 9, 1913, granted March 12, 1914 and recorded in Book 4 of water claims at page 208.

By consent of all parties the hearing in this proceeding:
was consolidated with the hearings in application No. 1432, Application No. 1231, Case No. 716, Case No. 724 and Supplemental
Application No. 118, all being proceedings affecting the Cuyamaca
Company. It was stipulated that the evidence taken in each of these
proceedings might be considered as having been offered and intro-

duced in each of the other proceedings. Public hearings in these proceedings were held in the City of San Diego on February 15, 16, 17, 18, 19 and 20 and April 12, 13, 14, 15, 16 and 17, 1915. The parties in certain of these proceedings requested authority to file briefs, which briefs have now been filed. The present proceeding is now ready for decision.

At the hearing, the City of San Diego filed it's Exhibit
No. 8 adding to the list of property described in Exhibit "B"
attached to the petition herein, being the exhibit which undertook
to describe the entire property of Cuyamaca Company, the following
items:

- 1. Pumping plant No. 4 (below diverting dam).
- 2. Pumping plant No. 5 (Miles Station).
- 3. Grossmont pump station.
- 4. La Mesa Dam pumping plant.
- 5. Telephone lines.
- 6. Miles Reservoir No. 2.
- 7. Measuring station below diverting dama
- 8. Measuring station at Old Mission Dam.
- 9. Boulder Creek weir.
- 10. Sand Creek cement shed.
- 11. Meteorological instruments.
- 12. Webster Reservoir.
- 13. South Fork cook snack.
- 14. Right of way for flowage and keeper's house at diverting dam.
- 15. Right of way for Kelly Ditch.

The City of San Diego also filed its Exhibit No. 15 containing additions to its Exhibit "C" attached to the petition herein. This exhibit adds to the property described in said Exhibit "C" attached to the petition herein four of the fifteen items described in City of San Diego's Exhibit No. 8, as follows:

Item No. 4 - La Mesa Dam pumping plant.

Item No. 5 - Telephone lines.

Item No. 14- Right of way for flowage and keeper's house at diverting dam.

Item No. 15- Right of way for Kelly Ditch.

Later in the hearing the City of San Diego filed as its
Exhibit No. 22, a copy of Ordinance No. 6104 of the Common Council
of the City of San Diego, amending Section 1 of Ordinance No. 5977,
being the ordinance under which these proceedings were initiated,
by adding thereto Section 1-a to include the following additional
lands, property and rights of the Cuyamaca Company:

- 1. The southeast quarter of northeast quarter of Section 7 and south half of northwest quarter and the southwest quarter of northeast quarter of Section 8, Township 15 South, Range 2 East, S.B.M. (Kuehner property).
- 2. All riparian rights and rights of diversion on and along the San Diego River, owned or controlled by James A. Murray, Ed Fletcher and William G. Henshaw, all as more particularly shown and described in Cuyamaca Company's Exhibit No. 30 in Application No. 1231.
 - 3. Kelly Ditch.
 - 4. a. Motors, pumps, pipe lines, wells and other equipment installed or in process of installation at El Monte pumping plant;
 - b. All pipe, casing and fittings located in El Cajon Avenue and installed during the years 1914 and 1915 for the purpose of delivering flood waters of the San Diego River to the City of San Diego;
 - c. 265 meters, varying in size from 5/8 inch to 3 inches;

all of which properties are described in City of San Diego's Exhibit No. 21 in this proceeding.

It appears that parcel No. 1, the Kuehner property, was already included in the original ordinance. The Kelly Ditch, while not specifically included in the original ordinance, was included in the City of San Diego's Exhibit No. 8. The description of the El Monte Pumping plant, as contained in the original ordinance, contains the following omnibus clause:

"Together with all wells, pumps, pumping plants, cil tanks, store houses and all other structures or personal property now situated, lying or stored thereon."

This language, which will be used in the description of the El Monte Pumping plant property contained in Exhibit No. 1 attached hereto, speaking as of the date of the decision herein, will cover Item

No. 4-a included in Ordinance No. 6104.

At the time the City of San Diego filed the copy of Ordinance No. 6104, being the City's Exhibit No. 22, the City also filed its Exhibit No. 21 containing a statement of certain additional properties consisting of the El Cajon Avenue lines together with the connection with the City of San Diego's main at Highland Avenue, the lines in the City of El Cajon, the master meters and certain additions to the El Monte pumping plant.

At the conclusion of the hearing, City Attorney Cosgrove requested that the City of San Diego's petition and schedules be considered as amended so as to include all property including all permits and privileges and all schedules, maps, charts and data concerning which testimony had been presented.

As the result of the original petition herein and of the various additions to the properties herein described, contained in the supplemental schedules filed by the City of San Diego, the Railroad Commission is now asked to fix and determine the fair compensation to be paid by the City of San Diego to Cuyamaca Company for two separate and distinct property schedules, as follows:

1. The entire property of the Cuyamaca Company with the exception of 601 acres retained by the Company near Cuyamaca Lake,

being the same property described in Exhibit No. 1 attached to the opinion and order this day rendered in Application No. 1432, being the joint application of Murray and Fletcher and La Mesa and Spring Valley Irrigation District.

2. A portion only of the property of the Cuyamaca Company, being all of the property referred to in the preceding paragraph, except the items which have been excluded from the original and supplementary schedules, as hereinbefore specifically set out.

The facts bearing on the value of the property of the Cuyamaca Company were fully discussed in the decision this day rendered in Application No. 1432. It would be surplusage to repeat here what was there said.

I find as a fact that the fair value of the property of Cuyamaca Company described in Exhibit "B" attached to the petition herein together with the additions thereto, being the property particularly described in Exhibit No. 1 which is attached to the opinion and findings herein, and made a part hereof, is the sum of \$745,000.

As already pointed out in the summary of the allegations of the petition herein, the City of San Diego requested that the Railroad Commission, if possible, determine separately and apart from the other portions of the property, the value of certain intangible items. Although I am anxious to accommodate the City of San Diego in this matter, I am of the opinion that such segregation can not be made. Whatever intangible items exist must be considered as enhancing the value of the utility's tangible properties. Spring Valley Water Works v. City and County of San Francisco, 192 Fed. 137, 167; Brunswick & Topsham Water District v. Maine Water Company, 99 Me. 371, 59 Atl. 537, 539. These intangible items can not be valued apart from the public utility system of which they are part and parcel. Accordingly, I regret my inability to follow the City's request in this particular.

It now becomes necessary to make a finding with reference to the compensation to be paid by the City of San Diego for that portion of the property of the Cuyamaca Company which is described in Exhibit "C" attached to the petition herein as modified at the hearing. This property will be described in Exhibit No. 2 which will be attached to the opinion and findings herein and made a part hereof. The dismemberment of the system of the Chyamaca Company as contemplated in this second schedule of properties will leave the properties remaining in the ownership of Cuyamaca Company of considerably less value than their value as a portion of the Company's entire system. In fact, certain of these properties, if segregated from the remaining properties, will have no value whatsoever. After careful consideration I find as a fact that the fair value of that portion of the lands, property and rights of the Cuyamaca Company which is described in Exhibit "C" attached to the petition herein, as modified at the hearing herein, being the property particularly described in Exhibit No. 2 attached to the opinion and findings herein, which exhibit is hereby made a part of the opinion and findings herein, is the sum of \$644,669.00 and that the severance damage to the property of Cuyamaca Water Company not taken will be the sum of \$32,966.12.

I recommend the following findings:

FINDINGS.

City of San Diego, a city incorporated under the laws of the State of California, having filed with the Rail-road Commission a petition setting forth the intention of said City to acquire under eminent domain proceedings the lands, property and rights of James A. Murray, Ed Fletcher and William

G. Henshaw engaged as co-partners under the firm name and style of Cuyamaca Water Company in the ownership and operation of a public utility water company in San Diego County, and asking the Railroad Commission to fix and determine the just compensation to be paid to said James A. Murray, Ed Fletcher and William G. Henshaw for the public utility and the lands, property and rights thereof and for the specified portion of said lands, property and rights, and public hearings having been held and the Commissioner who heard the evidence having made a personal inspection of said lands and property of said James A. Murray, Ed Fletcher and William G. Henshaw, and being fully apprised in the premises,

THE RAILROAD COMMISSION HEREBY FINDS AS A FACT that the just compensation to be paid by the City of San Diego to James A. Murray, Ed Fletcher and William G. Henshaw, doing business under the firm name and style of Cuyamaca Water Company for said Company's lands, property and rights as particularly described in the exhibit which is hereto attached, marked Exhibit No. 1 and made a part of these findings, is the sum of \$745,000.

THE RAILROAD COMMISSION HEREBY FINDS AS A FACT that the just compensation to be paid by the City of San Diego to James A. Murray, Ed Fletcher and William G. Henshaw, doing business under the firm name and style of Cuyamaca Water Company, for that portion of their lands, property and rights which is particularly described in Exhibit No. 2 attached to the opinion and findings herein and made a part thereof, is the sum of \$644,669.00 and that the severance damage to

the property of Cuyamaca Water Company not taken, which damages are to be paid by City of San Diego if the lands, property and rights described in said Exhibit No. 2 are taken, is the additional sum of \$32,966.12, making a total of \$677,635.12 as the just compensation to be paid by the City of San Diego.

The foregoing opinion and findings are hereby approved and ordered filed as the opinion and findings of the Railroad Commission of the State of California.
