FIRST SUPPLEMENTAL ORDER.

This Commission, in an order dated June 30,  
1915, in the above entitled applications, having au-  
thorized The Appleton Land, Water and Power Company  
to lease certain water utility properties in San Ber-  
nardino County to Hesperia Water Company, and having  
authorized the latter company to acquire said proper-  
ties and operate the same under a certificate of pub-  
lic convenience and necessity;

And said order having contained the following provisions, among others:

"This certificate of public convenience and necessity shall not become effective until Hesperie Water Company shall have filed a stipulation with this Commission and shall have received the approval of the Commission thereto by supplemental order, said stipulation to recite that Hesperie Water Company does not, and never shall, claim in any proceeding before this Commission, or any other public body, a value for the franchise granted to Hesperie Water Company by Ordinance No. 164 of the County of San Bernardino, in excess of the actual cost to Hesperie Water Company of acquiring said franchise."

"Before the lease herein authorized shall be finally executed, applicants shall present to this Commission satisfactory evidence that all of the consumers now served by The Appleton Land, Water and Power Company will continue to be served in the future either by Hesperie Water Company or The Appleton Land, Water and Power Company, and applicants shall secure from this Commission a supplemental order approving the same."

And The Appleton Land, Water and Power Company and Hesperie Water Company now having filed with this Commission the stipulations required in the above mentioned order,

IT IS HEREBY ORDERED that the stipulations filed by the applicants herein on July 19, 1915, and marked Exhibit "D" in Application No. 1693 and Exhibits "F" and "G" in Application No. 1694, be, and they are hereby, approved.

The foregoing First Supplemental Order is hereby approved and ordered filed as the First Supplemental Order of the Railroad Commission of the State of California.
