BY THE COMMISSION:

O R D E R .

The San Diego Consolidated Gas & Electric Company hav-
ing on March 1, 1909, executed and delivered to Harris Trust and
Savings Bank, an Illinois corporation, and Los Angeles Trust Com-
pany, a California corporation (the name of which corporation was
on September 10, 1909, changed to Los Angeles Trust and Savings
Bank), a deed of trust to secure a bonded indebtedness of Six
Million (\$6,000,000) Dollars, which deed of trust conveyed to
said Harris Trust and Savings Bank and said Los Angeles Trust
Company, as Trustees, all the property of every kind then owned,
or which thereafter might be acquired by the San Diego Consolidated
Gas & Electric Company, and which deed of trust also recited, in
Article II, Section 3:-

"The Company covenants that, upon the written
request of the Trustee, or either of them, it will forth-
with execute, acknowledge and deliver all such further and
supplemental instruments, and will take all such further
action, as may reasonably be required for better assuring
and confirming unto the Trustees the mortgaged property
or any part thereof."

and the trustees having made written request to the San Diego Consolidated Gas & Electric Company that said company execute and deliver to Harris Trust and Savings Bank and Los Angeles Trust and Savings Bank, as Trustees, a supplemental deed of trust conveying the property acquired by San Diego Consolidated Gas & Electric Company since March 1, 1909, the date of the original deed of trust, and San Diego Consolidated Gas & Electric Company having made application to this Commission for an order authorizing the execution by applicant of a supplemental deed of trust to Harris Trust and Savings Bank and Los Angeles Trust and Savings Bank, Trustees, a copy of which deed of trust is attached to the application and marked "Exhibit A,"

IT IS HEREBY ORDERED That San Diego Consolidated Gas & Electric Company be and the same hereby is authorized to execute to Harris Trust and Savings Bank and Los Angeles Trust and Savings Bank, Trustees, a supplemental deed of trust, which deed of trust shall be drafted substantially in the form and terms of the supplemental deed of trust attached to the application in this proceeding and marked "Exhibit A."
