SUPPLEMENTAL OPINION

Subsequent to Decision No. 3257 of this Commission, establishing a schedule of rates modifying those previously in effect in the City of Pittsburg, request was made by the defendant, BLACK DIAMOND WATER COMPANY, for postponement of the date upon which such rates should become effective, and during the interval the attorneys representing complainant and defendant

agreed at the office of this Commission that, pending complete metering of the system, the following modification of the flat rates established by that order should be made effective.

ent time, obtain and install sufficient meters to cover the entire system but has admitted ability and intention to immediately proceed with the installation of meters on three complete blocks in the City of Pitteburg, to be designated by the Commission's hydraulic engineers, and to proceed generally with the installation of meters at the rate of ten meters per month. Pending such installation, admittedly the flat rate schedule provided would not produce revenue equal to that previously obtained by the company or equal to that which the Commission believes the defendant company would realize provided the system were fully meter-

SUPPLEMENTAL ORDER

IT IS HEREBY ORDERED by the Railroad Commission of the State of California that the Black Diamond Water Company establish and charge the following schedule of rates for water:

MUNICIPAL:

Fire Service, \$70. per month minimum for 35 hydrants. Additional hydrants, \$1.50 per month per hydrant.

Street sprinkling and sewer flushing, 12¢ per 100 cubic feet for all water used.

Municipal buildings and departments at commercial rates.

COMMERCIAL:

Flat Rates:

Dwellings covering less than 500 square feet or occupied by four persons or less, containing one toilet,	
Dwellings covering more than 500 square feet when housing more than four persons, including one toilet,	1.50 per mo.
Business places covering less than 800 square feet	1.00 per mo.
Business places covering over 800 square feet	1.50 per mo.
Warehouses	1.50 per mo.
Saloons and hotel bar-rooms	3.00 per mo.

Metered Rates:

\$1.25 per month for 500 cubic feet or less. Next 500 cubic feet at 20¢ per 100 cubic feet. Use in excess of 1,000 cubic feet at 15¢ per 100 cubic feet.

Special contract rates for large consumers and industrial users, to be approved by the Railroad Commission. Meters to be installed at the expense of the company, at either the option of the company or upon request by the consumer.
