OPINIOM.

The authorization of this Commission is requested by San Gabriel Valley Water Company to sell its water plant and system and by the City of Alhambra to purchase said plant.

The authorization of this Commission is not necessary to permit a city to purchase a public utility plant; therefore, the order herein will be an anthorization to the Water Company to sell its plant.

The property to be sold consists of a water distributing system almost entirely in the City of Alhambra, together with land and water rights.

The price to be paid is \$320,000.00, plus the cost to the Company of additions and betterments made since the date of the offer of sale and up to the time of delivery of the plant to the City. The City has voted \$325,000.00 face value of bonds to purchase this plant.

In a rate fixing proceeding, Decision No. 2916, page 481, Vol. 8, Opinions and Orders of the Railroad Commission of California, this Commission found that the reasonable cost new of the plant here involved was \$320,000.00. That decision was made November 20, 1915, and at the hearing the evidence was that approximately \$10,000.00 had been expended on this plant by the Company subsequent to the date of the above finding, which sum has not been added to the price.

The cost of additions made subsequent to the date of the offer of sale will, in the judgment of the City Engineer of Alhembra, amount to a comparatively small sum.

The City will get a complete water plant with sufficient water available to adequately serve its needs and under all the circumstances I believe the price agreed upon is reasonable.

The Company now serves consumers from this plant in territory outside of the City and the City has agreed to continue such service.

I recommend that the application be granted conditioned upon the City filing with the Commission a stipulation agreeing to continue service of water in that territory described by meets and bounds in Exhibit "A" attached to the application herein.

I submit herewith the following form of order:

ORDER.

Application having been made by San Gabriel Valley Water Company for an order authorizing it to sell a certain water distributing system in and about the City of Alhambra. County of Los Angeles. State of California, together with land and water rights appertinent thereto, and a public hearing having been had and it appearing that said application should be granted upon certain conditions.—

IT IS HERREY ORDERED by the Railroad Commission of the State of California that SAN GABRIEL VALLEY WATER COMPANY be and the same is hereby authorized to sell, transfer and convey to the City of Alhambra all that certain water plant and system, including a distributing system, land and water rights located in and about the City of Alhambra, County of Los Angeles, California, which said property is more particularly described in Exhibit No.1, attached to this order and made a part hereof, reference to which is hereby made.

The purchase price to be paid said San Gabriel Valley Water Company for said property shall be the sum of \$320,000-00. plus the cost to said Company of additions and betterments made to said water plant subsequent to the date of the offer of sale made to the City of Albambra.

This order is made upon the condition that prior to the time when the sale of this property shall be finally consummated the City of Alhambra shall file with this Commission a stipulation agreeing on the part of said City to continue to serve with water that certain territory outside the present limits of said City known as Granada Park, which territory is now being served by the San Gabriel Valley Water Company, said territory comprising approximately 180 acres, being described as follows:

2nd. Part of the S.E. of Sec. 20, T. 1 S. R.

12 W. bounded as follows: Beginning at a point in the north line of said quarter section 438 feet easterly from the center line of said section: thence S. 180 58' W. 651.4 feet: thence S.110 30' W. 354 feet: thence S. 300 56' West. 288.4 feet: thence S. 180 35' E., 891.5 feet. more or less to a stake 20 feet northerly from the center line of the Pacific Electric Railway Company's track; thence S. 570 32' W., parallel with said railway track, 345.5 feet to the West line of said Quarter Section; thence S. to the S.W. corner of said Quarter Section; thence East to the common corner of Sections 20, 21, 28 and 29; thence W. to the place of beginning.

3rd. Part of the N.W. 2 of the S.W. 2 of Section 21. T. 1 S.. R. 12 W. bounded as follows: Beginning at a point in the West line of said quarter section 18.3 feet southerly from the N.W. corner of said quarter section; thence parallel with the northerly line of said Section S. 89° 50' E. 380.6 feet; thence S. 3° 34' E. 996.2 feet; thence S. 22° 57' E. 170 feet; thence S. 20° 47' E. 245.4 feet, more or less, to the south line of the N.W. 2 of the S.W. 2 of said Sec. 21; thence S. 89° 55' W. 930.64 feet to the west line of said Sec. 21: thence N. 0° 05' W. 1301.7 feet to the place of beginning."

The foregoing opinion and order me hereby approved and ordered filed as the opinion and order of the Railroad Commission of the State of California.

Description of Property to be Conveyed by San Gabriel Valley Water Company to the City of Alhambra.

let. Lot One (1), and that certain tract of land designated as "Reservoir", of Phillips Subdivision of a part of the Alhambra Addition Tract as per map thereof recorded in Book 14. Page 100. Miscellaneous Records of said County, together with reservoir thereon, known as Reservoir No. 1.

2nd. Also that certain right of way and easement over a ten foot strip in Lot Four (4) of said Phillips Subdivision of a part of the Alhambra Addition Tract as conveyed to the Alhambra Addition Water Company by deed from John Langdon and wife, dated August 31st, 1907, recorded in Book 3148 page 287 of Deeds in the office of the County Recorder of said County.

3rd. Lot One (1) in Range Eighteen (18) of the Alhambra Addition Tract as per map thereof recorded in Book 3, Pages 298 and 299 of Miscellaneous Records of said County, together with the reservoir thereon.

4th. Lots A and B of Oak Knoll Sheet "A" as per map thereof recorded in Book 10. Pages 114 and 115 of Maps in the office of said County Recorder of Los Angeles County.

5th. Lots L. M. N. O. P. R. S and T of Oak Knoll Sheet "C" as per map thereof recorded in Book 16, Pages 18 and 19 of Maps in the office of the County Recorder of said County, together with the reservoir located upon said Lot R.

6th. An easement for laying and maintaining a pipe line or pipe lines over a strip of land twenty (20) feet in width, lying easterly of and adjoining the easterly line of Kewen Drive, through Lots 90, 91, 92, 93, 95, 96, 97 and 98 of said Oak Knoll, Sheet "C", and through Lots 30 and 31 of Tract No. 2949, Sheet 3 as per Map Book 31, Pages 3, 4 and 5, Records of said County.

7th. The entire right, title and interest of the grantor in and to all water arising or flowing, developed or undeveloped, on, in, or under those cortain tracts of land known as (1) Oak Knoll Sheet "A" as per map thereof recorded in Book 10, Pages 114 and 115 of Maps in the office of the County Recorder of said County; (2) Oak Knoll Sheet "B" as per map thereof recorded in Book 10, Pages 118 and 119 of maps in the office of said Recorder; (3) Oak Knoll Sheet "C" as per map thereof recorded in Book 16 Pages 18 and 19 of Maps in the office of said Recorder; (4) and that certain five acre

tract, more or less, bounded westerly by Lot 33 of Oak Kholl, Sheet "B", northerly, and northeasterly by Lot S of the Oak Kholl Sheet "C" and easterly and southerly by Mill Lake and Old Mill Road; excepting therefrom and reserving to the said San Gabriel Valley Water Company, however, a quantity of water equivalent to that which would be produced by a constant flow of 50 miners inches annually of water under a 4 inch pressure and subject to the express condition that no more than 100 miners inches constant flow under a 4 inch presence may be withdrawn during any one day of 24 hours. Such reservation of such water shall also be subject to the further condition that it shall not be developed on any lands lying southerly of the following described line: Beginning at the most westerly corner of Lot Eighty-six (86) Oak Knoll. as per map recorded in Map Book 10. Pages 114. 115.
118 and 119 Records of Los Angeles County, California;
thence northeasterly along the northwesterly line of
Lots Eighty-six (86). Eighty-five (85). Eighty-four
(84). Eighty-three (83). and Eighty-two (82) of said Oak Knoll to the most northerly corner of said Lot Eighty-two (82); thence in a direct line to the most northerly corner of Lot Ninety (90) Oak Knoll Sheet , as per map recorded in Map Book 15 Pages 18 and 19 Records of said County; thence southeasterly along the northeasterly line of Lots Nine ty (90) and Nine tyone (91) of said Oak Knoll Sheet "C" to the southerly boundary line of the City of Pasadena; thence easterly along the said boundary line of the City of Pasadena to the easterly line of said Sheet "C" . The conveyance of water above described being subject, however, to any and all water now flowing or that may hereafter flow from the tunnels in said Lots Fifty-eight (58), Fifty-nine (59) and Sixty (60) of said Oak Knoll, Sheet "B", and to all water rights conveyed to W. P. Gardiner, et al., by deeds recorded in Book 263 at page 243, of deeds, and in Book 821 at page 13, of deeds, in the office of the Recorder of said County; grantor agreeing, however, that it will not extend said tunnels beyond their present point of development, but reserving the right to keep said tunnels in repair.
