KEFORE THE RATIROAD COMMISSION OF THE STATE OF CALIFORNIA.

In the Matter of the Application of the CASCADA AND HUNTINGTON LAKE STAGE COMPANY for certificate of public convenience and necessity to operate freight, passenger, express and baggage service between cascada, California, and Huntington Lake, California, and intermediate points.

APPLICATION NO. 3680.

ORDER

E. C. Tripp, Sr., R. W. Tripp, H. M. Tripp, E. C. Tripp, Jr., and Kenith Dowe, partners in business under the name of The Cascada and Huntington Lake Stage Company have petitioned the Railroad Commission for an order declaring that public convenience and necessity require the operation by them of an automobile stage line as a common carrier of freight, passengers, express and baggage between Cascada and Huntington Lake and intermediate points.

Applicants propose to operate a schedule that will make connection with all trains of the San Joaquin and Eastern Railroad at Cascada, and to operate a seasonal service terminating on October 31, of each year.

The proposed rates for the transportation of passengers, freight, baggage and express packages are to be in accordance with a schedule filed as an exhibit attached to the application in this proceeding.

The equipment to be used in the proposed service consists of the following:

One 22 ton 1917 model Moreland Truck, 40 horse-power, State Motor Vehicle Department License No. 391893

One 2 ton Kimball Truck, 1917 Model, 35 horse-power, State Motor Vehicle Department License No. 378971

One seven-passenger Locomobile Touring Car, 1915 Model 48, 63 horse-power, State Motor Vehicle Department License No. 257994.

Additional passenger equipment is to be supplied if the demands of traffic require it.

We are of the opinion that this is a matter in which a public hearing is not necessary and that the application should be granted.

THE RATIROAD COMMISSION HEREBY DECLARES that public convenience and necessity require the operation by E. C. Tripp, Sr., R. W. Tripp, H. M. Tripp, E. C. Tripp, Jr., and Kenith Dowe, partners in business under the name of The Cascada and Huntington Lake Stage Company, of an automobile stage and truck line as a common carrier of passengers, freight, baggage and express between Cascada and Huntington Lake and intermediate points, all in the county of Freeno; provided, that this declaration shall not become effective until said E. C. Tripp, Sr., H. M. Tripp, R. W. Tripp, E. C. Tripp, Jr., and Kenith Dowe have procured from the Railroad Commission a supplemental order herein reciting that the said E. C. Tripp, Sr., H. M. Tripp, R. W. Tripp, E. C. Tripp, Jr., and Kenith Dowe have filed herein a certified copy of permit from the Board of Supervisors of the County of Fresno, as provided by Section 3 of Chapter 213, Laws of 1917; and provided, further, that the rights and privileges herein granted shall not be assigned or transferred unless the written consent of the Railroad Commission to such assignment of transfer has first been procured.

IT IS HEREBY ORDERED that no vehicle may be operated

under this certificate unless such vehicle is owned by the applicants herein or is leased by such applicants under a contract or agreement on a basis satisfactory to the Railroad Commission.
