BY THE COMMISSION:

O R D E R .

IT IS HEREBY ORDERED That this Commission institute on its own initiative, under the provisions of Section 60 of the Public Utilities Act, an investigation to determine whether public convenience and necessity will be subserved by having a track connection made, under the provisions of Section 38 of the Public Utilities Act, between the tracks of the Petaluma and Santa Rosa Railway Company and the Northwestern Pacific Railroad Company within either the city of Petaluma, Sebastopol or Santa Rosa, Sonoma County, California.

BE IT FURTHER ORDERED That the Secretary of this Commission be and he hereby is instructed to notify said Petaluma and Santa Rosa Railway Company and said Northwestern Pacific Railroad Company to appear before this Commission at its office, 833 Market Street, San Francisco, California, on Monday, May 5, 1913, at 10 A. M., at which time and place said Petaluma and Santa Rosa Railway Company and the Northwestern Pacific Railroad Company may appear and be heard upon the matters involved in this proceeding.

BE IT FURTHER ORDERED That if either Petaluma and Santa Rosa Railway Company or the Northwestern Pacific Railroad Company

do not appear at said time and place, said company failing to so appear shall be deemed guilty of contempt of this Commission and subject to the penalties prescribed by the Public Utilities Act.
