OBINION

The original application herein seeks authority to operate passenger stage and truck service between Whitewater and Palm Springs. The amended application seeks authority to operate between Barming and Palm Springs via Whitewater, all in Riverside County.

A public hearing upon the application was held by Examiner Westover at Banning, August 1st.

Applicant has recently been awarded the contract to carry the United States mail between Whitewater on the Southern Pacific system and Palm Springs, a winter health resort, off the railroad, about ten miles to the

Springs appears to be well served by C. E. Bunker, Jr. who has been operating a freight and passenger line over that route for several years. Applicant testifies that additional service is not needed between those points. This was also shown by testimony on behalf of Mr. Bunker.

Applicant urges, however, that a through service from Banning to Palm Springs via Whitewater would prove a public convenience, but did not show that such a line would be apt to receive sufficient patronage to justify its establishment.

Applicant's testimony showed that there were frequent inquiries at the garage in Banning for stage accommodation to Palm Springs and that shipments of meat, ice. bakery goods and similar products from Banning. destined for Palm Springs, might be procured for the proposed truck service because these shipments by freight, express or parcel post are sometimes carried past Whitewater through error and delays in delivery result. Most of these shipments for Palm Springs originate at Los Angeles.

It appears from the testimony that most of the passenger travel to and from Palm Springs originates at or is destined to points west of Banning, usually Los angeles and vicinity. It does not sufficiently appear that such travelers would prefer to change from train to stage at Banning rather than at Whitewater and increase the stage journey by fourteen miles between Whitewater and Banning, especially as the road is reported to be in poor condition usually. The present stage service between Palm Springs and Whitewater affords good connection with passenger

trains in both directions. Public convenience and necessity does not appear to require the additional service proposed.

ORDER

JAMES A. GRAY having applied for declaration that public convenience and necessity require him to operate automobile stage and truck service between Banning and Palm Springs via Whitewater, all in Riverside County, a public hearing having been held thereon, and it appearing from the testimony that public convenience and necessity do not require the additional service proposed.

IT IS HEREBY ORDERED that the application be and it is hereby denied.
