All contracts with subscribers for the use of telephone instruments, or for the giving of telephone service which may be in existence with customers and subscribers of and other persons receiving telephone service from the Manteca Telephone and Telegraph Company, including all rights, whether in contract form or otherwise, for long distance service connections with any other telephone or telegraph company doing business in the State of California; also

All right to use the name of the Manteca Telephone and Telegraph Company whether said right consists in its use as a trade name or otherwise: also the goodwill of the business conducted by the undersigned under the name of the Manteca Telephone and Telegraph Company, and the undersigned hereby promises and agrees not to engage in telephone or telegraph business in the town of Manteca, San Joaquin County, California, or in this vicinity at any time after the execution and delivery of this bill of sale.

And it appearing to the Commission that this is not a case in which a public hearing is necessary and that the application should be granted, --

IT IS HEREBY ORDERED that the application herein be, and the same hereby is, granted; <u>provided</u> that the consideration given for the property authorized to be transferred shall not be taken before this Commission, or any other public body, as representing for rate fixing or other purposes the value of the property transferred. And, <u>provided further</u>, that the authority herein granted to transfer shall apply only to such transfer as is made on or before December 31, 1918.
