"An application having been filed with the Railroad Commission in which The Atchison, Topeka and Santa Fe Railway Company and the Santa Fe Land Improvement Company ask authority to transfer an undivided one-half interest in a certain parcel of land and railway tracks hereinafter described to the Southern Pacific Railroad Company, the properties after such transfer to be operated by the Southern Pacific Company and The Atchison, Topeka and Santa Fe Railway Company jointly, a public hearing having been held and the Commission being of the opinion that this application should be granted;".
