O R D E R

Frank J. Barton and Joseph L. and Mark W. Zerboni have applied to the Railroad Commission for an order approving the assignment, sale and transfer of the equipment and operative rights covering an express and baggage service between Santa Monica, Venice and Los Angeles, applicant, Frank J. Barton to assign and transfer and applicants, Joseph L. and Mark W. Zerboni to purchase, acquire and hereafter operate such express and baggage truck line.

The rights and privileges proposed to be transferred are those granted to Frank J. Barton under Decision Number 6519 on Application Number 4600, as decided July 24, 1919, the Railroad Commission having thereby made its order declaring that public convenience and necessity require the operation by Frank J. Barton of an automobile truck line as a common carrier of express and baggage between Santa Monica, Venice and Los Angeles.

The proposed transfer is to be made in accordance with an agreement of sale, a copy of such agreement being attached to the application herein and marked exhibit "A".

We are of the opinion that this is a matter in which a public hearing is not necessary and that the application should be granted.

IT IS HEREBY ORDERED that this application be and the same hereby is granted subject to the following conditions:

- I - Applicant Frank J. Barton, will be required to immediately cancel all tariffs and time schedules now on file with the Railroad Commission, such cancellation to be in accordance with the requirements of General Order No. 51 and other regulations of this Commission.
- II - Applicants, Joseph L. and Mark W. Zerboni, will be required to file new tariffs in their own name or to adopt as their own tariffs and time schedules as heretofore filed with the Railroad Commission by Frank J. Barton. All rates and tariffs to be the same as those heretofore filed by Frank J. Barton with the Railroad Commission.
- III - The rights and privileges, transfer of which are hereby authorized, may not again be transferred or assigned unless the written consent of the Railroad Commission to such transfer or assignment has first been secured.
- IV - No vehicle may be operated under this authority of transfer by applicants, Joseph L. and Mark W.

Zerboni unless such vehicle is owned by such applicants or is leased by them under a contract or agreement on a basis satisfactory to the Railroad Commission.
