**O R D E R**

Harry A. Wilson has petitioned the Railroad Commission for an order declaring that public convenience and necessity require the operation by him of an automobile stage service as a common carrier of passengers between Pasadena, Eagle Rock, Glendale, Hollywood, Ocean Park and intermediate points.

Applicant proposes to charge rates in accordance with a schedule marked exhibit "A" and filed with the application in this proceeding and to operate on a schedule leaving Pasadena at 7:00 A. M. daily and on a headway of one hour and thirty minutes thereafter throughout the day leaving Ocean Park at 7:00 A. M. and operating on a schedule of one and one half hour headway thereafter; using as equipment two Studebaker automobiles equipped with special bodies with seating capacity for twelve passengers.

The service proposed does not parallel the line of existing transportation companies, either stage or rail, with the exception of the territory between Hollywood and Ocean Park and as to such territory the service directly parallels and duplicates that of the Pacific Electric Railway Company.

We are of the opinion that this is a matter in which a public hearing is not necessary and that the application should be granted; provided, however, that no local service be rendered between Hollywood and Ocean Park.

THE RAILROAD COMMISSION HEREBY DECLARIES that public convenience and necessity require the operation by Harry A. Wilson of an automobile stage line as a common carrier of passengers between Pasadena and Ocean Park via Eagle Rock, Glendale and Hollywood; provided, however, that this declaration does not convey authority to applicant to carry local passengers between Hollywood and Ocean Park and authority hereby conveyed covering the transportation of through passengers between the territory Pasadena to Hollywood inclusive. To and from Ocean Park local passengers to be carried only between Hollywood and Pasadena.

IT IS FURTHER ORDERED that the rights and privileges hereby granted may not be transferred nor assigned unless the written consent of the Railroad Commission to such transfer or assignment has first been secured.

IT IS HEREBY ORDERED that no vehicle may be operated under this certificate unless such vehicle is owned by the applicant or is leased by such applicant under a contract or agreement on a basis satisfactory to the Railroad Commission.
