## ORDER

Carl C. Allen and J. C. Walling, C. H. Alexander and Carl C. Allen, a co-partnership, proposing to operate under the fictitious name of Fresno-Kingsburg Stage Company, have petitioned the Railroad Commission for an order authorizing the transfer of the operative rights of a certain stage line between Fresno and Kingsburg; applicant, Carl C. Allen, desiring to sell and transfer and applicants, Walling, Alexander and Allen, as a co-partnership under the fictitious name of Fresno-Kingsburg Stage Company, desiring to purchase, acquire and hereafter operate such stage line.

The transfer of the proposed stage line is to be made in accordance with an agreement, a copy of which has been attached to the application in this proceeding and is marked exhibit "A".

The rights and privileges for which approval of transfer is requested are those heretofore granted to applicant, Carl C. Allen, by an approval of transfer from A. C. McVey as approved

by the Railroad Commission in its Decision No. 6591 on Application No. 5150, decision dated December 17, 1919.

We are of the opinion that this is a matter in which a public hearing is not necessary and that the application should be granted.

IT IS HEREBY ORDERED that this application be and the same hereby is granted subject to the following conditions:

- Applicant, Carl C. Allen, will be required to immediately cancel all tariffs and time schedules now on file with the Railroad Commission, such cancellation to be in accordance with the provisions of General Order No. 51 and other regulations of the Railroad Commission.
- II Applicants, Walling, Alexander and Allen, as a co-partnership under the fictitious name of Frosno-Kingsburg Stage Company, will be required to file new tariffs under the name of said partnership,or to adopt as their own the tariffs and schedules heretofore filed with the Railroad Commission by applicant, Carl C. Allen, all rates to be the same as those now filed with the Railroad Commission by applicant, Carl C. Allen.
- III The rights and privileges, transfer of which are hereby authorized, may not again be transferred nor assigned unless

the written consent of the Railroad Commission to such transfer or assignment has first been secured.

IV - No vehicle may be operated under this authority of transfer by applicants, Walling, Alexander and Allen, a co-partnership, unless such vehicle is owned by such applicants or is leased by them under a contract or agreement on a basis satisfactory to the Railroad Commission.
