Tho richts and privilegos, which are proposed to bo leased, are those acquirod by applicent, Zl Dorado Stage Company, i corporation, by reason of said company oparating in good faith prior to 1ray 1,2917 , and continuonely to the proeent timo; Moy 1, 1917, being the date recognized by Legisiature as that upon which operators

It good seith wore not roquired to secure a cortisiceto of proisc conTonienco and necossity from the Easiroad commission nor porifts emom the governjng bodies of all poistical aub-divisions through which the route passea.

We are of the opinion tiat this is a matter in which a public hoaring is not nocoesary and that tho application shorid be grantod.

In IS EEREBY CRDERED that this application bo, and tho same beioby, is granted, subjoct to the following conditions:-
(2)-Applicant, EI Dorado Stege Compony, 下inI be reguired to immedately cancoli all tarifis and timo schodale now on siIe with the Railrose Commfseion, such canceliation to be mado in sccordance With tho provisione of General Orier No. 51, and otkor regmiations of the Bailroad Commiseion.
(2)-AppIさcont, NoIte Sus Iino, Inc., a coIm pazation, Will be reotaired to $\pm 110$ now tariffs and scinedules in its orm name or to adopt as its own, the tarififs and time schedules herctolore filed with the Railrond Comiesion by opplicant, El Dorado Stago Company, 511 rates snd Lares to be in accordanco with those horctosore 9110 d Wth the Railroad Commesion by applicant, El Dorado Stage Company.
(3)mere rigits and privileges, trancier of mhich are horeby atthorived undor lease may not again be transforred, Ieased or aseigned, valoss tho writton consent of tho Raflroad Commesion to such tranofer, lease or assignment has firet been socurca.
(4)-NTo vehicie may be operated by appiicant, Thito Bus Iinc, Inc., wniess such rehicie is omed by suid applicant or is leased oy it undor a contract or agreement on a basis satiefactory to the zasiroad Comission.
