BY THE COMMISSION:

O R D E R

E. D. Brizard and D. L. Zahner have made application to the Railroad Commission requesting authority for the sale and transfer of certain operative rights in an automotive passenger stage service between Eureka and Rohnerville, both in Humboldt County, California, the applicant, E. D. Brizard, desiring to sell and the applicant, D. L. Zahner, desiring to purchase, acquire and hereafter operate such service.

The operative rights transfer of which is herein requested, are those acquired by the applicant, E. D. Brizard, under this Commission's Decision No. 7503, rendered April 30, 1920, on Application No. 5000.

The transfer of the rights and privileges herein is to be made in accordance with an agreement accompanying and filed with the application in this proceeding.

The Commission is of the opinion that this is a matter in which a public hearing is not necessary and that the application should be granted.

IT IS HEREBY ORDERED that this application be and the same is hereby granted, subject to the following conditions:

1st- That the applicants E. D. Brizard and D. L. Zahner, will, within twenty (20) days from the date of service hereof, file in writing, with the Railroad Commission, an acceptance of this order and the conditions contained herein.

2nd- That the applicant, E. D. Brizard, will be required to immediately cancel his tariff of fares and time schedule now on file with the Railroad Commission, such cancellation to be made in accordance with the provisions of General Order No. 51 and other regulations of the Railroad Commission.

3rd- That the applicant, D. L. Zahner, will be required to immediately file tariff of fares and a time schedule, in duplicate, or to adopt as his own the tariff and time schedule heretofore filed with the Railroad Commission by E. D. Brizard, all fares to be identical with those heretofore filed by applicant, E.D.Brizard, such tariff and time schedule, or adoption thereof, to be made in accordance with the provisions of General Order No. 51 and other regulations of the Railroad Commission.

4th- That the rights and privileges of transfer hereby authorized may not again be transferred, sold, leased, discontinued nor assigned unless the written consent of the Railroad Commission to such transfer, sale, lease, discontinuance or assignment has first been secured.

5th- No vehicle may be operated under this authority

for transfer by applicant, D. E. Zahner, unless such vehicle is owned by him or is leased by him under a contract or agreement on a basis satisfactory to the Railroad Commission.
