BY THE COMMISSION:

ORDER

An application having been filed for a certificate declaring that public convenience and necessity require the operation by applicant of automobiles for the transportation of passengers for compensation between Los Angeles and Warner's Hot Springs, by way of Riverside, Perris and Hemet: a public hearing having been held thereon before Examiner Gordon at Los Angeles on June 21, 1920, and testimony given on behalf of applicant and of Pickwick Stages, Southern Division, and Motor Transit Company, appearing as protestants; and it appearing from such hearing that public convenience and necessity require the partial exercise only of the privilege sought as

set forth in the following order:

NOW, THEREFORE, the RAILROAD COMMISSION OF THE STATE OF CALIFORNIA HEREBY DECLARES THAT PUBLIC CONVENIENCE AND NECESSITY REQUIRE the operation by applicant of automobiles for the transportation of passengers for compensation between Riverside and Warner's Hot Springs, and intermediate points by way of Perris and Hemet, subject to the following terms and conditions:

- 1. The declaration of public convenience and necessity herein made does not include the transportation of passengers locally between Riverside and Hemet and intermediate points, and the operations herein authorized are limited to exclude such local traffic.
- 2. Within ten (10) days after being notified of this order, applicant shall file with the Railroad Commission a witten acceptance of the certificate herein granted, and shall also file time schedules and tariffs proposed to be used in said operations, which said schedules and tariffs must be approved by this Commission before operations shall commence.
- 3. Within thirty (30) days after the granting of this certificate applicant shall commence to operate pursuant thereto if, within said time, the tariffs and schedules have been approved; but in the event that said tariffs and schedules shall be approved more than thirty (30) days after the granting of this certificate, operations shall commence within ten (10) days after notice of such approval.

4. Failure to comply with any of the conditions
herein mamed shall be deemed a voluntary surrender
of this certificate, and revocation thereof by this
Commission.
