SECOND SUPPLEMENTAL OFDER.

WHEREAS, applicants in the above entitled matter report that by inadvertence and mistake, an error was made in the description of the real property owned by and intended to be granted by MOUNTAIN LIGHT AND WATER COMPANY to BOULDER CREEK ELECTRIC LIGHT AND WATER COMPANY (now Santa Cruz County Utilities) in that a certain lot heretofore owned by Mountain Light and Water Company was included in the description; and

WHEREAS, Mountain Light and Water Company is no longer the owner of said lot, which is described herein, and therefore asks the Reilroad Commission to modify its order in Decision No. 8008, deted August 26, 1920;

NOW, THEREFORE, IT IS HEREBY ORDERED, that the order in Decision No. 8008, dated August 26, 1920, be, and it is hereby, modified so as to permit Mountain Light and Water Company to make, execute and deliver its grant deed to SANTA CRUZ.COUNTY UTILITIES conveying all of the properties described in Exhibit "A" attached to Decision No. 8008, except the following:

"SIXTH, Also, the following tract of land, Commencing at the northeastern corner of the lot corveyed by Brockdale Land Company to May L. Halstead by deed dated May 15, 1909, and recorded on the day of in Volume of Deeds, page records of said Santa Cruz County, which lot is situate on the west side of Cascade Street in said Town of Brockdale, and running thence Morth 18° 45' East (Mag) a distance of about 110 feet to the southeastern corner of the lot conveyed by J.H. Logan and W.T. Jeter to Clara S. Ward by deed dated March 28, 1908, and recorded on the day of in Volume 203 of Deeds, page 344, records of said Santa Cruz County; thence running North 712° West to the center line of Clear Creek, thence Southerly following the center line of said Clear Creek to a point where said center line of said Clear Creek to a point where said center line of said Clear Creek intersects a line drawn North 57-3/4° West (Mag) from the point of commencement: thence along said line South 57-3/4° East to the point of commencement. Being designated as Lot 11, Block F as the same is so marked and designated on the Map of Brookdale, Santa Cruz County, California, printed by the Union Lithograph Company of San Francisco, California; together with all improvements thereon."

The foregoing property shall be excluded from the mortgage and/or deed of trust which SANTA CRUZ COUNTY UTILITIES has been authorized to execute.

IT IS HEREBY FURTHER ORDERED, that the order in Decision No. 8008, dated August 26, 1920, as amended, shall remain in full force and effect, except as modified by this Second Supplemental Order.
