O R D E R

In this proceeding United Stages, Inc. has applied to the Railroad Commission for an order authorizing it to lease to Harry M. Hunt certain operative rights authorizing the operation of an automobile stage line for the transportation of passengers between Oxnard and Santa Paula, serving as intermediate points Saticoy Junction, Saticoy and El Rio.

The operative rights herein proposed to be leased were obtained by the United Stages, Inc. under Decision No. 7515 in Application No. 5629, dated April 30th, 1920, which decision authorized one J. Lou Hall to sell and the United Stages, Inc. to purchase the operative rights of the former between the points above named.

Under the lease, a copy of which is attached to the application herein, United Stages, Inc. proposes to lease to Harry M. Hunt such operative rights for a period of one year at an annual rental of \$180.00, reserving to itself the right to operate its through Santa Barbara stages between Oxnard and El Rio.

Harry M. Hunt, lessee under the proposed lease agreement,
is at the present time engaged in the operation of passenger
stage line in the County of Ventura and if the present application
is granted he proposes to connect up the leased operative rights
with his existing routes.

It appearing to the Commission that this is a matter in
which a public hearing is not necessary and that the application
should be granted,

IT IS HEREBY ORDERED that the above entitled application
be, and the same hereby is granted, subject to the following con-
ditions.

1. That the amount to be paid as annual rental under
the lease agreement herein provided, shall never be urged
before this Commission or any other rate fixing body as a
measure of value for rate fixing or other purposes.

2. That applicant Harry M. Hunt shall immediately
adopt as his own the tariff of rates and time schedules at
present on file with the Railroad Commission by the United
Stages, Inc., covering operation of passenger stage service
under the operative rights herein authorized to be leased
to applicant Harry M. Hunt.

3. That applicant United Stages, Inc., shall im-
mediately cancel all tariffs of rates and time schedules
covering service under the operative rights herein authorized
to be leased, such cancellation to remain in effect during
the pendency of the lease herein authorized.
