ORDER

Railroad Company, a corporation, has made application to the Railroad Commission for a certificate of public convenience and necessity authorizing the establishment of an automobile stage line
for the transportation of passengers, baggage and express between
Spreckels, California and Salinas, California, and intermediate
points.

Applicant herein is at the present time engaged in the operation of a steam railroad between the points above named, but states that due to the fact that its operation has been conducted at a considerable yearly deficit, it is of the opinion that it can materially reduce operating expenses through the operation of automobile stages in lieu of certain of its passenger trains which are operated during the middle of the day and receive at the present time a very light patronage

Applicant includes as Exhibit "D" with its application herein a statement of revenues and expenses for the last five years, such statement showing a surplus of \$5,420.67 for the year 1916 and deficits for the next four years ranging from a maximum of \$46,741.49 for the year 1919 to a minimum of \$10,694.95 for the year 1920. None of such figures include taxes or interest.

The rates to be charged on the automobile stage line are to be the same as those charged for the railroad transportation between the same points by applicant herein and the time schedules for the automobile stages will be the same as those now published by applicant for its steam trains. Automobile stages to be operated whenever traffic conditions warrant.

It appearing to the Commission that this is a matter in which a public hearing is not necessary and that the application should be granted.

THE RAILROAD COMMISSION OF THE STATE OF CALIFORNIA HEREBY DECLARES that public convenience and necessity require the establishment by Pajaro Valley Consolidated Railroad Company, a corporation, of an automobile stage line as a common carrier of passengers, baggage and express between Spreckels and Salinas. California, and intermediate points, and a certificate of public convenience and necessity be, and the same hereby is granted subject to the following conditions:

- l. That applicant Pajaro Valley Consolidated Railroad Company, a corporation, shall file with the Railroad Commission its written acceptance of the certificate herein granted within period of not to exceed ten days, and shall file within a period of not to exceed twenty days, tariff of rates and time schedules, in duplicate, in accordance with the provisions of General Order No. 51 and other regulations of the Railroad Commission, and shall also begin operation of the service herein authorized within a period of not to exceed forty days.
- 2. That the rights and privileges hereby authorized may not be discontinued, sold, leased, transferred nor assigned unless the written consent of the Railroad Commission to such discontinuance, sale, lease, transfer or assignment has first been secured.
- 3. That no vehicle may be operated by the applicant unless such vehicle is owned by said applicant or is leased by it under a contract or agreement on a basis satisfactory to the Railroad Commission.
