ORDER

In this proceeding Frank B. Zadikian and Tatos Avoian have applied to the Railroad Commission for an order authorizing them to sell and George Abajian for an order authorizing him to purchase the operative right authorizing the operation of an automobile truck line for the transportation of milk between Los Angeles, Chino, Wine-ville, Pomona and El Monte.

The operative right herein proposed to be transferred was obtained by Zedikian and Avoian through transfer from Mrs. C. W. Mingus, as administratrix of the Estate of C. W. Mingus, deceased, being Application No. 7063, Decision No. 9336, dated August 9, 1921.

Applicants give as consideration to be paid for the property herein proposed to be transferred the sum of \$1,000.00. This amount does not include any sum representing the value of equipment proposed to be transferred as the proposed purchaser has available for use in this service two 2-ton Nash trucks and one 1-ten Ford truck.

The present holders of the certificate covering this route are unable to continue the service due to the fact that they have only one truck which is at the present time kat in condition for operation and as the commodity transported must be moved regularly each day the operative right should be transferred to a responsible individual who has the financial ability to maintain a regular and efficient service.

It appearing to the Commission that this is a matter in which a public hearing is not necessary and that the application should be granted.

IT IS HEREBY ORDERED that the above entitled application be, and the same hereby is granted subject to the following conditions:

- l. That the consideration to be paid for the property herein authorized to be transferred shall never be urged before this Commission or any other rate fixing body as a measure of value for rate fixing or any other purposes, excepting the transfer herein authorized.
- 2. That the applicants Frank B. Zadikian and Tatos Avoian will be required to immediately cancel all tariffs and time schedules now on file with the Railroad Commission, such cancellation to be in accordance with the provisions of General Order No. 51 and other regulations of the Railroad Commission.
- 3. That the applicant George Abajian will be required to immediately file tariff and time schedule, in duplicate, in his own name, or to adopt as his own the tariffs and time schedules heretofore filed by Frank B. Zadikian and Tatos Avoian, all rates and time schedules to be identical with those filed by Zadikian and Avoian.
- 4. That the rights and privileges herein authorized to be transferred may not be discontinued, sold, leased, transferred nor assigned unless the written consent of the Railroad Commission to such discontinuance, sale, lease, transfer, or assignment has first been secured.
- 5. That no vehicle may be operated by the applicant George Abajian, unless such vehicle is owned by said applicant or is lessed by him under a contract or agreement on a basis satisfactory to the Railroad Commission.
