BY THE COMMISSION -

ORDER ON PETITION FOR REHEARING

Upon further consideration of the record in the above entitled proceedings, in the light of the oral argument had on October 3, 1933, and good cause appearing therefor,

IT IS HEREBY ORDERED that a rehearing be granted in Cases No.3325 and 3342, insofar as said proceedings relate to the rates for wharf demurrage on canned goods, dried fruit, beans, steel sheets and tomato puree.

IT IS HEREBY FURTHER ORDERED that a rehearing of all other matters involved in Cases Nos.3324, 3325, 3341 and 3342 be and it is hereby denied.

IT IS HEREBY FURTHER ORDERED that the effective date of the order in Cases Nos.3325 and 3342, insofar as they relate to the rates for wharf demurrage on canned goods, dried fruit, beans, steel sheets and tomato puree be and it is hereby extended until further order of the Commission.

IT IS HEREBY FURTHER ORDERED that the rehearing of Cases No.3325 and 3342, insofar as it relates to the rates for wharf demurrage on canned goods, dried fruit, beans, steel sheets and tomato puree, be held before Commissioner Harris on Thursday, the 9th day of November, 1933, at 10:00 a.m., in the Court Room of the Commission, State Building, San Francisco, California.
