PRICING

O P I N I O N

The Gray Line, Inc. requests authority to reroute its sightseeing Tours Nos.7 and 12 to Marin county points and to adjust rates by reduction. Tour No.7 is to be reduced in mileage from 58 to 54 miles, the rates to be \$5.50 for bus and \$6.00 (as amended), for limousine. The change in this route is by elimination of that portion between Manzanita and Toll Gate, via Alto and Mill Valley, and adoption of the new road via Tamalpais Valley and Rock Springs Gate. Tour No.12 is reduced from 64 miles to 27 miles to permit a half day trip and the rates are fixed at \$3.00 for bus and \$3.50 for limousine. Both trips visit Muir Woods. Tour No.7 visits Mt. Tamalpais.

This is a matter in which a public hearing is not necessary. The application will be granted.

O R D E R

IT IS HEREBY ORDERED that The Gray Line, Inc. be and it is hereby authorized to reroute its service on Tour No.7, as authorized by Decision No.23018, dated October 23, 1930, and Tour No.12, as authorized by Decision No.20422, dated November 1, 1928, as follows:

MT. TAMALPAIS, MUIR WOODS, AND MARIN COUNTY SCENIC TOUR.
54 miles -- Bus \$5.50, Limousine \$6.00 (as amended).

Starting from 781 Market Street at 9:30 A.M. daily to Stockton Street, to Golden Gate Ferry to Sausalito, thence along U. S. Highway 101 to Manzanita, thence Mill Valley Road to Dolan's Corners, thence Bolinos Road to Rock Springs Ranch, turn right to Summit Toll Gate to Muir Woods, whence passengers alight and visit woods.

Returning to Summit Toll Gate turn left on Stinson Beach Road to Tamalpais Toll Gate, right to Rock Springs and to the summit where passengers will be conducted around the mountain.

Return to Rock Springs, follow Ridge Crest Fall Road to Alpine Road, Alpine Road to Fairfax, thence to San Anselmo, Ross and San Rafael, thence to San Quentin, thence to Greenbrae and U. S. Highway 101 to Sausalito and Golden Gate Ferry to San Francisco.

Time allowed for this trip - 8 hours.
Fare includes ferry fares and toll charges.

MUIR WOODS SCENIC TRIP -
27 miles -- Bus \$3.00, Limousine \$3.50

Starting from 781 Market Street at 1:30 P.M. daily to Stockton Street, to Golden Gate Ferry, to Sausalito, thence along U. S. Highway 101 to Manzanita, to Dolan's Corners, to Mill Valley Toll Gate, to Mill Valley, to Muir Woods, where passengers alight and are conducted through the Woods.

Return to Mill Valley Toll Gate, thence to Mill Valley, thence Mill Valley Road to Manzanita and U.S. Highway 101, to Sausalito, Golden Gate Ferry to San Francisco.

Time allowed for this trip - 4 hours.
Fare includes ferry fares and toll charges.
