<u>OPINION</u>

Laurence E. Miles herein applies for the renewal of a Motor Carrier Transportation Agent's License.

A public hearing on this application was conducted before Examiner Handford at Los Angeles, the matter was duly submitted and is now ready for decision.

Applicant held a Motor Carrier Transportation Agent's License No. 21, for the year 1933, same having been issued by this Commission in accordance with the provisions of Chapter 390, Statutes of 1933.

Applicant proposes to establish his office and to hereafter sell tickets at No. 6715 Pacific Boulevard, Huntington Park, Los Angeles County. From the record herein it appears that applicant in his endeavor to sell transcontinental tickets over line for which he acted as agent has furnished prospective patrons with information as to safety of travel and liability as to accident hazards, said information not always being correct and it is suggested that in future applicant give out to his prospective patrons only such information that is known to be correct and that will not influence patrons unduly as regards their selection of a proposed route.

ORDER

A public hearing having been held on the above entitled application and the Commission being now fully advised,

IT IS HEREBY ORDERED that a renewal of the Motor Carbe riers' Transportation Agent's License/granted to Laurence E. Miles, said renewal license to authorize Laurence E. Miles to act as a Motor Carriers' Transportation Agent with location at No. 6715 Pacific Boulevard, Huntington Park, Los Angeles County and authorizing said Miles to sell and negotiate for the sale of automobile stage line transportation over the stage lines of the following carriers:
