O R D E R

Southern California Telephone Company, a corporation operating a telephone and telegraph system in the State of California, herein makes application for authority to make effective charges for the installation of colored hand set telephones, together with certain conditions governing such installations.

The proposed schedule, as shown in Exhibit "A" attached to the application, sets forth certain charges for the installation and replacement of regularly stocked colored hand sets. Charges for the installation, where practicable, of hand telephone sets in colors and types other than those listed will be based upon the cost to the Telephone Company of providing the special finish and later restoring the equipment to standard black finish.

It appears that these charges are for special equipment infrequently required and that a public hearing in the matter is not necessary, therefore,

IT IS HEREBY ORDERED that Southern California Telephone Company be and it is hereby authorized to file with the Railroad

Commission on or before May 31, 1934, effective for service on and after June 10 1934, the schedule of charges for colored hand set telephones as set forth in Exhibit "A" attached hereto.

SUPPLEMENTAL EQUIPMENT - COLORED TELEPHONE SETS

ALL EXCHANGES

SERVICE:

Applicable to Colored Telephone Sets furnished within the Exchange Area of all exchanges, when other than the standard black finish is provided.

CHARGE:

(2) Other Telephone Sets and Hand Sets in Other Colors:

Standard telephone sets, in colors and types other than as shown above will be provided, where practicable, at an installation charge based on the estimated cost to the Company in providing the special finish and later restoring the equipment to the standard black finish.

CONDITIONS:

1. The above charges apply to each installation and to each complete or partial replacement of colored telephone sets when made at the request of the applicant or subscriber. These charges do not apply to replacements of colored telephone sets initiated by the Company and required for the proper maintenance of the equipment or service.

2. The above charges cover only the special finish provided. Exchange service rates, together with service connection and move and change charges, apply in connection with service furnished with colored telephone sets, in the same manner as with standard black telephone sets.

3. Charges shown in paragraph (1) for hand set mountings with applique base and for subsets apply to common battery installations only.
