O R D E R

Pacific Gas and Electric Company, a corporation, and Auburn-Chicago Mining Company, a California mining company, having filed an application with the Railroad Commission requesting approval of a written agreement substantially in accordance with the words and figures as written in the form therefor marked Exhibit "A" and attached to the application herein and entered into by and between the above mentioned parties, said agreement providing, among other things, for the sale and delivery to said Auburn-Chicago Mining Company for mining purposes near Penryn, Placer County, when and if available, of surplus water in Pacific Gas and Electric Company's Red Ravine Canal not exceeding a flow of three (3) miner's inches, (1) to be paid for at the rate of thirty cents (30¢) per miner's inch day, (2) and said agreement to be effective for a period of one (1) year from and after the date of its execution and thereafter until terminated at the election of either Pacific

1. A miner's inch for the purpose of this agreement shall mean 1.5 cubic feet of water per minute.

2. A miner's inch day for the purpose of this agreement shall mean one (1) miner's inch as heretofore defined flowing for a period of twenty-four (24) hours.

Gas and Electric Company or Auburn-Chicago Mining Company by service on the other party of written notice to that effect thirty (30) days in advance of the date on which such termination shall become effective, and it appearing that this is not a matter in which a public hearing is necessary and that the application should be granted,

IT IS HEREBY ORDERED that Pacific Gas and Electric Company, a corporation, and Auburn-Chicago Mining Company, a California mining company, be and they are hereby authorized to enter into an agreement for the delivery of surplus water under substantially the same terms and conditions as are set forth in the form of agreement marked Exhibit "A" attached to the application herein and made a part hereof by reference.

IT IS HEREBY FURTHER ORDERED that the Pacific Gas and Electric Company, a corporation, file with this Commission, within thirty (30) days from the date of this Order, two certified copies of said agreement as finally consummated.

The authority herein granted shall become effective on the date hereof.
