
Decision No. 27471.

BEFORE THE RAILROAD COMMISSION OF THE STATE OF CALIFORNIA

In the Matter of the Application of LONG BEACH TRANSFER AND WAREHOUSE COMPANY, a California corporation, and Lyon Van & Storage Co., a California corporation, for permission to transfer the assets and franchise of Long Beach Transfer and Warehouse Company to Lyon Van & Storage Co.

OPINION AND ORDER

In this proceeding the Railroad Commission has been asked to make an order authorizing the transfer of the assets, operative right and business of the Long Beach Transfer and Warehouse Company, a corporation located at Long Beach, California, to Lyon Van & Storage Co.

The explication sets forth that all of the shares of Long Beach Transfer and Warehouse Company, excepting the shares held by Directors for the purpose of qualifying them as such Directors, now are and at all times have been held and owned by Lyon Van & Storage Co.; that applicants propose to transfer all of the assets of Long Beach Transfer and Warehouse Company, including the aforesaid franchise, to Lyon Van & Storage Co. and thereafter to dissolve Long Beach Transfer and Warehouse Company; that no consideration will be given by Lyon Van & Storage Co. for the aforesaid transfer of said assets, including said franchise, but the consent by all of the shareholders of Long Beach Transfer and Warehouse Company will be obtained

to such transfer.

Copy of Resolutions adopted by the Board of Directors of Long Beach Transfer and Warehouse Company and Lyon Van & Storage Co. authorizing the transfer is attached to and made a part of the application.

Lyon Van & Storage Co. will continue to operate the warehouse as a public utility under rates, rules and regulations shown in Werehouse Tariff C.R.C. No. 1, effective May 20, 1920, filed in name of Long Beach Transfer and Warehouse Company. The proposed transfer will not result in any curtailment of service.

We are of the opinion that this is a matter not requiring a formal hearing and that the application should be granted; therefore IT IS HEREBY CRDERED that the above entitled application be

and it is hereby granted, subject to the following conditions:

- 1. Long Beach Transfer and Warehouse Company and Lyon Van & Storage Co. shall join in common supplement to the tariff now on file with the Railroad Commission, applicant Long Beach Transfer and Warehouse Company on the one hand withdrawing and applicant Lyon Van & Storage Co. on the other hand accepting and adopting such tariff.
- 2. The rights and privileges herein authorized to be transferred may not be sold, leased, transferred or assigned, nor service thereunder discontinued, unless the written consent of the Railroad Commission to the sale, lease transfer or discontinuance has first been secured.

The effective date of this order shall be twenty (20) days

from the date hereof.
