OPINION AND ORDER

C. H. Ottney and C. F. Quiggle, co-partners doing business under the firm name and style of Ottney Warehouse Co., having filed the above emtitled application, and applicant G. H. Ottney having requested permission to sell, transfer and convey to applicant C. F. Quiggle his partnership interest in and to the business, assets, properties and privileges, franchises and permits of said partnership for the sum of \$9,404.90, payment to be made not later than November 15, 1935, in accordance with the terms and conditions of the Agreement for Pertnership Dissolution, dated January 30, 1935, filed as Exhibit A, and the Commission being of the opinion that this is not a matter in which a public hearing is necessary, and that the application should be granted, as herein provided,

IT IS HEREBY ORDERED that G. H. Ottney be, and he hereby is,

authorized to sell, transfer and convey to C. F. Quiggle his interest in and to the business, assets, properties, rights, privileges, franchises and permits of Ottney Warehouse Co., a co-partnership, such sale, transfer and conveyance to be made in accordance with the terms and conditions of the Agreement for Partnership Dissolution filed in this proceeding as Exhibit A, subject to the following conditions:

- 1. The consideration to be paid for the property herein authorized to be transferred shall never be urged before this Commission or any other rate fixing body as a meas-ure of value of said property for rate fixing or any pur-pose other than the transfer herein authorized.
- 2. G. H. Ottney and C. F. Quiggle shall within twenty (20) days after the effective date of the order, join in sup-plement to the teriffs on file with the Railroad Commission in name of Ottney Warehouse Co., applicant G. H. Ottney on the one hand withdrawing and applicant C. F. Quiggle on the other hand accepting and adopting as his own such tariffs and all effective supplements thereto.
- 3. The rights and privileges herein authorized to be conveyed may not be sold, leased, transferred nor assigned, nor service thereunder discontinued, unless the written consent of the Railroad Commission to such sale, lease, transfer, assignment or discontinuance has first been secured.
