## OPINION AND ORDER

M. Bernardo, operating under the name of Chico - Red Bluff Freight Line has petitioned the Railroad Commission for an order approving the sale and transfer by him to George W. Mullins of an operating right for an automotive service for the transportation of property between Chico and Red Bluff and intermediate points of Nord, Cana, Vina, Los Molinos, Tehema, Gerber and Proberta, and George W. Mullins has petitioned for authority to purchase and acquire said operating right and to hereafter operate thereunder, the sale and transfer to be in accordance with an agreement, a copy of which, marked Exhibit "A", is attached to the application herein and made a part thereof.

The consideration to be paid for the property herein proposed to be transferred is given as \$300.00 which is declared to be the value of the intangibles. No equipment is to be transferred.

The operating right herein proposed to be transferred was created by Decision No. 15494 dated October 7, 1925 on Application No. 10860.

We are of the opinion that this is a matter in which a public hearing is not necessary and that the application should be granted.

George W. Mullins is hereby placed upon notice that "operative rights" do not constitute a class of property which should be capitalized or used as an element of value in determining reasonable rates. Aside from their purely permissive aspect, they extend to the holder a full or partial monopoly of a class of business over a particular route. This monopoly feature may be changed or destroyed at any time by the state which is not in any respect limited to the number of rights which may be given.

IT IS HEREBY ORDERED that the above entitled application be, and the same is hereby granted, subject to the following conditions:

> 1. The consideration to be paid for the property herein authorized to be transferred shall never be urged before this Commission or any other rate fixing body as a measure of value of said property for rate fixing, or any purpose other than the transfer herein authorized.

2. Applicant M. Bernardo shall within twenty (20) days after the effective date of the order unite with applicant George W. Mullins in common supplement to the tariffs on file with the Commission covering service given under certificate herein authorized to be transferred, applicant M. Bernardo on the one hand withdrawing, and applicant George W. Mullins on the other hand accepting and establishing such tariffs and all effective supplements thereto.

3. Applicant M. Bernardo shall within twenty (20) days after the effective date of the order withdraw time schedules filed in his name with the Railroad Commission and applicant George W. Mullins shall within twenty (20) days after the effective date of the order file, in duplicate, in his own name time schedules covering service heretofore given by epplicant M. Bernardo, which time schedules shall be identical with the time schedules now on file with the Railroad Commission in the name of applicant M. Bernardo or time schedules satisfactory to the Railroad Commission.

4. The rights and privileges herein authorized may not be sold, leased, transferred nor assigned, nor service thereunder discontinued, upless the written consent of the Railroad Commission to such sale, lease, transfer, assignment or discontinuance has first been secured.

5. No vehicle may be operated by applicant George W. Mullins unless such vehicle is owned by said applicant or is leased by him under a contract or agreement on a basis satisfactory to the Railroad Commission.

6. The authority granted to sell and transfer the right and/or property shall lapse and be void if the parties hereto shall not have complied with all the conditions within the periods of time fixed herein unless, for good cause shown, the time shall be extended by further order of the Commission.
