## ORDER

S. G. Goucher, owner of Haddock Villa Water System, having asked permission to sell and transfer and American States Water Service Company of California, a corporation, having asked for authority to buy the public utility water works known as Haddock Villa Water System serving consumers in territory in the County of Los Angeles, adjacent to the City of Los Angeles, and bounded on the north by Colden Avenue, on the east by Vermont Avenue, on the south by 99th Street and on the west by Normandie Avenue, and the Commission being of the opinion that this is not a matter in which a public hearing is necessary and that this application should be granted as herein provided, now, therefore,

IT IS HEREEY ORDERED that S. G. Goucher be and he is hereby authorized to sell and transfer to American States Water Service Company of California, a corporation, and said American States Water Service Company of California, a corporation, is

hereby authorized to purchase the public utility water system known as Haddock Villa Water System, such sale and transfer to be made under the terms and conditions of the proposed DEED, ASSIGNMENT AND BILL OF SALE filed in this proceeding as Exhibit "C" which is hereby made a part of this Order by reference.

IT IS HEREBY FURTHER ORDERED that American States Water Service Company of California, upon coming into possession of the public utility property hereby authorized to be transferred, be and it is hereby authorized to apply to the water consumers in the territory served by the Haddock Villa Water System the rates, rules and regulations applicable to the American States Water Service Company of California on its Miller System, adjacent thereto.

The authority herein granted is subject to the following conditions:

- The authority herein granted shall apply only to such transfer as shall be made on or before the first day of June, 1935, and a certified copy of the final instrument of conveyance shall be filed with this Commission by S. G. Coucher within thirty (30) days from the date on which it is executed.
- 2. Within ten (10) days from the date on which said S. G. Goucher actually relinquishes control and possession of the property herein authorized to be transferred, he shall file with this Commission a certified statement indicating the date upon which such control and possession were relinquished.
- 3. The consideration for the transfer herein authorized shall not be urged before this Commission or any other public body as a finding of value for rate-fixing or any purpose other than the transfer herein authorized.

For all other purposes, the effective date of this Order
