THIRTEENTH SUPPLEMENTAL ORDER

IT APPEARING that this Commission in Decision No. 9412 provided for the establishment of basic rates and an oil clause in the application of Schedule No. 3 and that thereafter this Commission in Decision No. 27750 modified said basic rates and oil clause so applying to Schedule No. 3, and it further appearing that certain other conditions such as to the filing of affidavits as provided by said Decision No. 9412 still remain in effect, and it appearing desirable that in order to avoid the necessity of the filing of applications under both of said decisions and the confusion resulting therefrom, there be incorporated in a supplement to said original Decision No. 9412 a modified oil clause, together with the basic rates established in said Decision No. 27750;

NOW, THEREFORE, IT IS HEREBY ORDERED that the following basic rate and oil clause be and it is hereby established and that

the same shall hereafter be used in lieu of the basic rate and oil clause established and set forth in Schedule No. 3, Decision No. 9412: --

"The above rate, except for the first 500 cu. ft., is subject to decrease on the basis of 3 cents per 1,000 cu. ft. for each 10 cents decrease in the cost of oil below the price of \$1.65 per barrel f.o.b. San Diego, upon approval of the Railroad Commission of the State of California. Change to be to the nearest one cent."

IT IS HEREBY FURTHER ORDERED that in all other respects the provisions of said Decision 27750 and the provisions of said Decision No. 9412, except in so far as they may have been modified by the terms of this order and all previous orders supplementary thereto, shall remain in full force and effect.
